Chap 436 An Act to appropriate to Schoeffler & Wendte, the sum therein named.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is hereby appropriated to Schoeffler & Wendte, publishers of the Wisconsin Banner, out of any money in the treasury not otherwise appropriated, the sum of forty-five dollars and twenty-five cents, in full for publishing notice of the judicial election in the second judicial circuit, in 1852, and for furnishing five hundred copies of said paper containing the governor's message in the German language, for the use of the senate.

SECTION 1. There is hereby appropriated to B. W. Brisbois, treasurer of Crawford County, to be paid out of the school fund, the sum of one hundred and thirty dollars, in full payment for money paid on the 14th of May, 1849, by said county, to Isaac Spencer and Edward P. Lockart, for

subdividing and appraising a portion of the sixteenth sections of school lands in said county.

SEC. 2. This act shall take effect and be in force from and after its passage.

Radcliff, Thomas Thompson, and Frederick Rumblich, up to the third of April, 1852, and for committing and discharging the above named state prisoners, and in full for carriage hire, teams, and expenses of self and assistants in removing said prisoners from Milwaukee to Wanpun.
