

Treasury quarterly on warrants of the Governor, and paid to the persons entitled to receive the same, which sum shall be in full for salaries of Commissioners, Assistants, rent of rooms, and all other expenses incident to said survey, exclusive of printing the annual reports of said Commissioners.

§ 7. This act shall take effect and be in force from and after its passage.

### Chap. 41.

Published, April 14.

AN ACT to change the time for holding the Spring Term of the Circuit Court of Fond du Lac county for the year 1856 [7].

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

§ 1. The Spring Term of the Circuit Court for the [county of] Fond du Lac for the year 1857, shall be holden on the third Monday in April, instead of the fourth Monday in March, as now provided by law.

Time changed for holding Circuit Court.

§ 2. This act shall take effect and be in force from and after its passage, and all acts or parts of acts contravening the provisions of this act are hereby repealed.

### Chap. 42.

Published, April 8, 1857.

AN ACT to regulate the Boundaries of La Crosse and Trempeleau Counties.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

§ 1. That towns number twenty-two (22) and twenty-three (23), north of range four (4), five (5) and six (6) west, and towns nineteen (19), twenty (20), twenty-one

(21) and twenty-four (24), north of range five (5) and six (6) west, in the county of La Crosse, are hereby attached to and shall hereafter be constituted a part of Jackson County.

§ 2. The main channel of the Black River north of the line, between townships number seventeen and eighteen north, shall hereafter be the boundary line between the counties of La Crosse and Trempeleau, and all that part of La Crosse county, heretofore lying north or west of the said main channel of the Black River, as above described, is hereby attached to and shall hereafter be and constitute a part of Trempeleau county, and all that part of Trempeleau county heretofore lying south or east of said main channel of the Black River, is hereby attached to, and shall hereafter be, and constitute a part of La Crosse county.

§ 3. This act shall take effect and be in force from and after its passage.

### Chap. 43.

AN ACT to authorize the Secretary of State to audit a certain account.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

Sec. of State to

§ 1. The Secretary of State is hereby authorized to audit the account of Atwood & Rublee, for furnishing to the Superintendent of Public Property, copies of the Gubernatorial trial in the Supreme Court, in case of *Bashford vs. Barstow*, ordered by resolution of the Assembly, adopted February 7th, 1857. Said account shall be accompanied with a certificate of the Superintendent of Public Property, setting forth the number of copies of said work that were ordered and delivered under said resolution, which account shall be audited by the Secretary of State at the price at which the same work ordered by the last Legislature was audited; and he shall draw a warrant on the Treasury for the
