

CHAPTER 108.

[Published March 27, 1861.]

AN ACT to amend Chapter 142 of the Revised Statutes, entitled
 "Of the partition of lands owned by several persons."

*The People of the State of Wisconsin, represented in Senate
 and Assembly, do enact as follows:*

Who not an un-
 known owner.

SECTION 1. Section eleven of chapter one hundred and forty-two of the revised statutes, entitled "Of the partition of lands owned by several persons," is hereby amended by adding thereto the following: "provided, that no person whose title or interest appears of record, or who is in the actual possession or occupancy of any of said lands, shall be considered or proceeded against as an unknown owner."

SECTION 3. This act shall take effect from and after its passage.

CHAPTER 109.

AN ACT to amend Section 49 of Chapter 386 of the General Laws of 1860, entitled "An act to amend Chapter 18 of the Revised Statutes, entitled 'Of the Assessment and Collection of Taxes,'" approved March 18th, 1859, as amended by Chapter 295 of the General Laws of 1860, approved March 31st, 1860.

*The People of the State of Wisconsin, represented in Senate
 and Assembly, do enact as follows:*

Blanks to be fur-
 nished assessors.

SECTION 1. Section forty nine of chapter 386 of the general laws of 1860, entitled "An act to amend chapter 18 of the revised statutes, entitled 'Of the assessment and collection of taxes,'" approved March 18th, 1859, as amended by chapter 295 of the general laws of 1860, approved March 31st, 1860, is hereby amended by adding to said section forty-nine the following: "And it shall be the duty of each of said clerks to cause to be printed for the use of the assessors of each of the several towns, cities and incorporated

villages in his county, such number of said blanks as may be necessary; said printing to be paid for out of the county treasury.”

CHAPTER 110.

[Published March 27, 1861.]

AN ACT to amend Section 64 of Chapter 19 of the Revised Statutes, entitled “Of Highways and Bridges.”

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Insert after the word “necessary” in the fifth line of section 64 of chapter 19 of the revised statutes, entitled “Of highways and bridges,” the words “and such jury may increase or diminish the amount awarded by the supervisors.” ^{Awards.}

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 111.

[Published March 27, 1861.]

AN ACT authorizing the Attorney General to procure an abstract of title to certain property mortgaged by Edward H. Jansen to Charles Kuehn, late State Treasurer, and for an appropriation of money to defray the expense of procuring such abstract.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. The attorney general is hereby authorized and directed to procure an abstract of title to certain property mortgaged by Edward H. Jansen to Charles Kuehn, late state treasurer, to secure the state from loss. ^{Abstract.}
