## CHAPTER 325.

[Published May 2, 1863.]

AN ACT to incorporate the Baraboo collegiate institute.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. That D. P. Crandall, Herbert Hunting-Trustees-their ton, Tyrell Thomas, C. A. Clark, C. C. Cowles, E. powers. Martin, and their successors, be and are hereby created a body corporate and politic, under the name and style of "Baraboo collegiate institute," and shall be trustees of said corporation, for the purpose of maintaining and conducting an institution of learning, and, by said corporate name, to remain in perpetual succession, with full power to sue and be sued, plead and be impleaded; to receive, acquire and hold property, real and personal, by bequest, donation or purchase, and to sell, dispose of and convey the same; to have a common seal, and use, alter and renew the same; to appoint the requisite professors and teachers, and to grant such literary honors and degrees as they may deem proper: provided, that the advantages and honors of the institution shall be alike attainable by both sexes.

SECTION 2. The said trustees shall have control of Further powers. all funds and property that have heretofore or may hereafter be conveyed to said institution, and shall faithfully apply the same, to the best of their judg-

ment, for the benefit of the institution. The said trustees shall also have power to fix the time and place of their meetings, and a majority of their number, which may be increased to eighteen, shall constitute a quorum for the transaction of business.

Trustees to be

Section 3. The term of office of said trustees shall be three years, one third of whom shall be elected annually. The first board of trustees shall be divided into three classes. The first class shall hold their offices one year, the second class two years, and the third class three years; and the offices thus vacated shall thereafter be annually filled by an election for three years, or to fill vacancies: provided, always, that the trustees shall hold their offices until others are chosen.

Location—ex-

SECTION 4. The said institution shall be located at Baraboo, Sauk county, Wisconsin, and the library, apparatus, cabinets, furniture, buildings and lands, not exceeding twenty-five acres, belonging to said corporation, actually used by the said institution for the purposes thereof, and for no other purpose, shall be exempt from taxation.

No sectarian test.

SECTION 5. No test of a sectarian character shall be required of any officer, professor, teacher or student in this institution.

First meeting of trustees.

SECTION 6. The board of trustees hereby incorporated, shall hold their first meeting under this act, on the first Tuesday in May, 1863, and afterwards shall meet on their own adjournment, or upon a call of a majority of said board.

Section 7. This act shall take effect from and after

its passage.

## CHAPTER 326.

[Published May 4, 1868.]

AN ACT granting to William Hughes the right to keep and maintain a ferry across the Wisconsin river, in the county of Juneau.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Authority to build ferry.

SECTION 1. William Hughes, his associates and assigns, and their legal representatives, shall have the
