

## CHAPTER 330.

[Published May 23, 1865.]

AN ACT to vacate a certain block in the village of Trempealeau, in the state of Wisconsin.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

SECTION 1. All the public square lying south of <sup>vacated.</sup> block sixteen, in Noyes and Winkleman's addition to the village plat of the village of Trempealeau, in the county of Trempealeau, and all the alley between said public square and said block sixteen, are hereby vacated.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 331.

[Published May 20, 1865.]

AN ACT to amend chapter 478 of the general laws of 1864, entitled "an act to accept the grant of lands made to the state of Wisconsin, by the United States, to aid in the construction of a military road from Fort Howard, Green Bay, to the Michigan state line," approved April 4th, 1864.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

SECTION 1. Section three of chapter four hundred seventy-eight of the general laws of one thousand eight hundred sixty-four, is hereby amended, so as to read as follows : "The said commissioners shall cause the proposed line of said road to be surveyed, and proper grades therefor to be established, and plans and specifications for the necessary bridges, and for the contract for construction, to be made. The said road shall be constructed with sufficient drains and ditches, and not less than forty feet in width, with a grade not less than sixteen feet wide, with such gradation and

bridges as shall permit of its regular use as a wagon road, in all seasons of the year.”

SECTION 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 332.

[Published May 23, 1865.]

AN ACT to vacate a part of the village plat of Mayville, in Dodge county.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Vacated.

SECTION 1. Lots five, six, seven and eight, in block No. 2, in Naber's addition to the village of Mayville, in the county of Dodge, and state of Wisconsin, as said lots are described in the recorded plat of said addition, are hereby vacated.

How lands to be appraised.

SECTION 2. The lands upon which said lots have been laid out, shall hereafter be appraised and assessed irrespective of subdivisions into lots: *provided*, that nothing contained in this act shall be so construed as to prevent the sale and conveyance for delinquent taxes, of any portion of said lands as platted, which taxes have been heretofore levied.

Taxes not affected.

SECTION 3. This act is hereby declared a public act, and shall take effect from and after its passage.
