AN ACT to legalize the election of trustees of "the Evansville cemetery association," and to reorganize and revive the said corporation.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The election of Elijah Robinson, Henry meetion, &c. of G. Spencer, Levi Leonard, Samuel Cadwallader and trustees legal-David L. Mills, as trustees of "the Evansville cemetery association," at a meeting called and held by the proprietors of lots in said cemetery, for that purpose, in Evansville, in Rock county, on the sixth day of February, 1865, and the classification of said trustees elect at said meeting, by the chairman and secretary thereof, are hereby declared legal and valid; and the said as- Association resociation having been heretofore organized under and by virtue of chapter sixty-seven of the revised statutes, and not having held a meeting to elect trustees for the last six years, is hereby revived and reorgnized, and the property and franchises of said corporation are hereby declared to continue, and vest in the said corporation hereby revived and reorganized, and [shall] be under the management and control of the said trustees elect and their successors, in the same manner and with the like effect as if the said corporation had held an election annually, and elected and appointed trustees and officers of the said corporation, as required by said chapter sixty-seven of the revised statutes: pro- Proviso. vided, that nothing in this act contained shall be construed to legalize or in any manner affect the acts and doings of the late officers of the said corporation.

SECTION 2. The secretary appointed by the said Record of pro-trustees elect, is hereby authorized to enter at length ing. in the records of said corporation, the minutes and proceedings of said meeting and election of trustees, held February 6th, 1865, as aforesaid, together with the call or notice for said meeting, signed by the proprietors of lots in the said cemetery; and when so recorded, the same shall be part of the records of the said corporation.

SECTION 8. This act shall take effect and be in force from and after its passage.

CHAPTER 91.

AN ACT to legalize the official acts of Francis L. Warner, a justice of the peace of the town of Sun Prairie, in the county of Dane.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. All the official acts and duties of Francis L. Warner, who was duly elected a justice of the peace, in April, eighteen hundred and sixty-four, of the town of Sun Prairie, in the county of Dane, are hereby legalized and made as valid, for said year eighteen hundred and sixty-four, as though the said Francis L. Warner had caused his official bond and oath to be filed within the time prescribed by the statutes of this state.

SECTION 2. This act shall take effect and be in force from and after its passage.
