CHAPTER 208.

[*Published March 17, 1874.*]

AN ACT to appropriate a sum of money to the Hospital for the Insane at Madison, for the current expenses for the year 1874.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :

SECTION 1. There is hereby appropriated out of any money in the general fund not otherwise appropriated, the sum of sixty thousand dollars in full for the payment of current expenses at the Hospital for the Insane at Madison for the year 1874; and also the further sum of five thousand dollars for the construction of gas works and repairs.

Sum appropriated \$60,000 for current expenses—gas works \$5,000.

SECTION 2. All sums for current expenses shall be drawn from the treasury not oftener than quarterly in advance.

SECTION 3. This act shall take effect and be in force from and after its passage and publication, and shall be printed in the volume of general laws for the year 1874.

CHAPTER 209.

[*Published March 14, 1874.*]

AN ACT to appropriate a sum of money to the Institution for the Education of the Blind for the current expenses for the year 1874.

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows :

SECTION 1. There is hereby appropriated out of any money in the general fund not otherwise appropri-

Sum appropriated \$15,000.

ated, the sum of nineteen thousand dollars in full for the payment of current expenses at the Institution for the Education of the Blind, for the year 1874.

For current expenses when may be drawn.

SECTION 2. All sums for current expenses shall be drawn from the treasury, not oftener than quarterly, in advance.

SECTION 3. This act shall take effect and be in force from and after its passage and publication, and shall be printed in the volume of general laws for the year 1874.

CHAPTER 210.

[*Published March 23, 1874.*]

AN ACT relating to the publication of the report of the secretary of state as commissioner of insurance.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

When and how published.

SECTION 1. It shall be lawful for the secretary of state to publish his report as commissioner of insurance at the time and in the manner provided by law for the publication of the reports of state officers, and he may in his discretion include such report with his report as secretary of state.

Time of publication changed.

SECTION 2. Such report shall be in lieu of the publications now required by law on or before the first day of May in each year.

SECTION 3. This act shall take effect and be in force from and after its passage.
