### CHAPTER 219.

AN ACT to amend section eight of chapter twenty-two of the general laws of 1879, entitled “an act to facilitate the execution of the trusts assumed by the state of Wisconsin by the her acceptance of the grants of land made by acts of congress, approved respectively June 3d, 1856, and May 5th, 1864, to aid in the construction of certain railroads in said state.”

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Section eight of chapter twenty-two of the general laws of 1879, entitled “an act to facilitate the execution of the trusts assumed by the state of Wisconsin by her acceptance of the grants of land made by acts of congress approved respectively June 3, 1856, and May 5th, 1864, to aid in the construction of certain railroads in said state,” is hereby amended by striking out the word “each,” where the same occurs before the word “county,” in the last line of said section, and inserting in lieu thereof the word “such.”

### CHAPTER 220.

AN ACT to authorize the issuing of patents to deceased persons in certain cases.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. In all cases where patents for lands belonging to the state of Wisconsin have been or may hereafter be issued in pursuance of any law of this state, to a person who had died, or who shall hereafter die, before the date of such patent, the title to the land

designated therein shall inure to and become vested in the heirs, devisees or assignees of such deceased patentee, as if the patent had issued to the deceased person during life.

SECTION 2. This act shall be in force from and after its passage.

### CHAPTER 221.

AN ACT to pay to John Thiel a sum of money therein named.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

Appropriation,  
\$18,000.

SECTION 1. There is hereby appropriated to John Thiel, deputy treasury agent at Schleisingsville, Wisconsin, the sum of eighteen dollars, to reimburse him for moneys collected of John Hinkel as special tax for dealing in live stock, and paid to the state; the same having been recovered by said Hinkel of said Thiel by suit, on the ground that said Hinkel was not liable to such tax.

SECTION 2. This act shall be in force from and after its passage and publication.

### CHAPTER 222.

AN ACT to appropriate to Edward C. Wall a sum of money therein named.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Appropriation,  
\$150.00.

SECTION 1. There is hereby appropriated out of the general fund, to Edward C. Wall, one hundred and fifty dollars for his expenses in defending his right to a seat in this assembly, against the claim made thereto by William P. McLaren.

SECTION 2. This act shall take effect from its passage and publication.
