CHAPTER 65.

AN ACT to authorize George Grimmer, Alexander Trudell and William Bruemmer, their heirs or assigns, to maintain a dam across Scarbro creek, in Kewaunee county.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

May build a dam.

SECTION 1. George Grimmer, Alexander Trudell and William Bruemmer, their heirs or assigns, are hereby authorized to maintain a dam across the Scarbro creek, in Kewaunee county, on lands owned by Alexander Trudell and William Bruemmer, to-wit: The southwest quarter ($\frac{1}{4}$) of the southeast quarter ($\frac{1}{4}$) of section twenty-five (25), town twenty-four (24), range twenty-three (23) east. Said dam to be maintained and used for manufacturing purposes, and for the purpose of facilitating the driving of saw logs down said creek. The aforesaid persons, their heirs or assigns, shall build suitable slides in said dam for running saw logs down said creek. The aforesaid persons, their heirs or assigns, shall build suitable slides in said dam for running saw logs belonging to any and all other persons free of expense or charge.

SECTION 2. The right is hereby reserved to the state to alter, amend or repeal any or all the provisions of this act.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 67.

AN ACT to authorize the maintenance of a bridge across Rock river in the city of Beloit.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Bridge over Rock river.

SECTION 1. The city of Beloit is hereby authorized and empowered to maintain the bridge now constructed and existing across Rock river on Bridge street in said city, and to alter or rebuild the same, and maintain the same as so altered or rebuilt, and to construct and maintain any other

suitable bridge in the place and stead thereof. And in so altering or rebuilding such existing bridge, or in constructing any such new bridge, said city may locate the westerly pier or abutment of the same, so that the easterly face or line thereof shall be and extend as far east as the easterly line of either of the brick blocks now erected on Bridge street at the westerly end of said bridge, known as Hackett's block and Merrill's block; and said city may fill in said Bridge street on the westerly side of said pier or abutment, up to the grade of said street, and so as to exclude the water of said river from the westerly side of said westerly pier or abutment of such bridge.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 68.

AN ACT to amend section 1 of chapter 9 of the general laws of 1879, relating to special terms of the circuit court in the seventh judicial circuit.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section 1 of chapter 9 of the general laws of 1879, is hereby amended by striking out the word "and" before the word "Wood" in the third line of said section, and inserting after said word "Wood" the words "and Waushara," so that said section when so amended shall read as follows: Each and every general term of the circuit court held in the counties of Marathon, Portage, Waupaca, Wood and Waushara shall be special terms for the whole seventh judicial circuit. Amended.
