CHAPTER 495.

AN ACT to create section 401m of the statutes, relating to a biennial examination of the financial transactions and accounts of the state normal schools, and making an appropriation therefor.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. There is added to the statutes a new section to read: Section 401m. 1. The board of regents of the state normal schools shall cause all of the financial transactions and accounts of or relating to the several state normal schools under their supervision at the close of each biennial period to be fully and thoroughly examined by an audit company of recognized business standing and reliability, and approved of by the governor and in no way connected with any such schools or with any of their activities.

2. Such examination shall be commenced immediately after the close of said period and be completed as soon as practicable.

3. Upon the completion of such examination a full and detailed report thereof shall be made by such audit company to the governor, and a printed copy of such report shall be furnished to each member of the next legislature not later than thirty days prior to the beginning of the next regular session.

4. A sum sufficient to carry out the provisions of this act is hereby appropriated out of any money in the state treasury not otherwise appropriated.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 496.

AN ACT to attach the town of Hobart, Brown county, to the second assembly district of Brown county and to the second senatorial district.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The town of Hobart in Brown county, which was created by the county board of Brown county pursuant

to chapter 338, laws of 1901, is attached to and made a part of the second assembly district of Brown county and is attached to and made a part of the second senatorial district.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 497.

AN ACT to create section 383m of the statutes, relating to a biennial examination of the financial transactions and accounts of the state university, and making an appropriation therefor.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. There is added to the statutes a new section to read: Section 383m. 1. The board of regents of the state university shall cause all of the financial transactions and accounts of or relating to the state university in any of its departments at the close of each biennial period to be fully and thoroughly examined by an audit company of recognized business standing and reliability and approved of by the governor and in no way connected with the university or with any of its activities.

2. Such examination shall be commenced immediately after the close of said period and be completed as soon as practicable.

3. Upon the completion of such examination a full and detailed report thereof shall be made by such audit company to the governor, and a printed copy of such report shall be furnished to each member of the next legislature not later than thirty days prior to the beginning of the next regular session.

4. A sum sufficient to carry out the provisions of this act is hereby appropriated out of any money in the state treasury not otherwise appropriated.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.
