

SECTION 5. There is further appropriated the sum of five hundred dollars to pay the expense of grading and improving that portion of Washington street in the village of St. Croix Falls which lies wholly within said park.

SECTION 6. The commission is hereby authorized to lay out and open, in co-operation with the village board of the village of St. Croix Falls, a public highway running from Washington street, in the village of St. Croix Falls, to Alabama street, the cost of grading and maintaining said highway to be paid by the village of St. Croix Falls.

SECTION 7. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 561.

AN ACT authorizing the governor to co-operate with the Waukesha county historical society, in erecting a monument at the birthplace of W. B. Cushing, and making an appropriation therefor.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. The governor is hereby authorized to co-operate with the Waukesha county historical society in erecting a monument at the birthplace of W. B. Cushing, in the town of Delafield, Waukesha county, and there is hereby appropriated out of any money in the state treasury, not otherwise appropriated, a sum sufficient to carry out the provisions of this act, not exceeding the sum of five thousand dollars.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 562.

AN ACT validating the publication of the report of the inspector of apiaries and the payment of the expenses incurred in such publication, and appropriating one hundred sixty-seven dollars and seventy-six cents to N. E. France to reimburse him for the expense of the publication of the report for 1910.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. The act of the inspector of apiaries in procuring the publication of reports and the auditing and payment of

vouchers for the expense incurred in such publication are hereby validated.

SECTION 2. There is hereby appropriated to N. E. France, out of the sum of seven hundred dollars made available by section 1494f of the statutes, for the payment of the expenses of the inspector of apiaries, the sum of one hundred sixty-seven dollars and seventy-six cents, which sum shall be deducted from the appropriation made in such section for the year ending June 30, 1911.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 563.

AN ACT to amend subdivision (b) of subsection 1, of section 4562d, of the statutes, relating to the hunting of deer.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subdivision (b), of subsection 1, of section 4562d, of the statutes, is amended to read: (Section 4562d) 1. (b) Any deer in the counties of Grant, La Fayette, Green, Rock, Walworth, Kenosha, Racine, Milwaukee, Waukesha, Jefferson, Dane, Iowa, Crawford, Richland, Sauk, Columbia, Dodge, Buffalo, Washington, Ozaukee, Sheboygan, Fond du Lac, Green Lake, Pepin, Marquette, Adams, Vernon, Monroe, La Crosse, Wausara, Winnebago, Calumet, Manitowoc, Outagamie, Brown, Ke-waunee, Portage and Waupaca at any time * * *.

SECTION 2. All acts or parts of acts conflicting with any of the provisions of this act are repealed in so far as they are inconsistent therewith.
