CHAPTER 110.

AN ACT to create section 2001—9a of the statutes, relating to the disposition of the property of the Church of Christ or Christian Church.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is added to the statutes a new section to read: Section 2001—9a. Whenever any local religious society of the denomination known as the Church of Christ or the Christian Church, shall become defunct or be dissolved, the property thereof shall vest in the Wisconsin christian missionary association, the state institution of said denomination, and if within three years from the date when such local society shall become defunct or be dissolved it shall be reincorporated in the manner prescribed in sections 1990 to 1994, inclusive, of the statutes, the said property so belonging to such defunct or dissolved local corporation at the time of its dissolution shall vest in such new corporation. Any local religious society shall be deemed defunct within the meaning of this section when it shall have ceased to maintain at least one regular service per month for a period of two years. The provisions of section 1996 shall not apply to or affect religious societies of the denomination known as the Church of Christ or the Christian Church.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 111.

AN ACT to create section 98m of the statutes, relating to the state flag.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is added to the statutes a new section to read: Section 98m. 1. The Wisconsin state flag is of dark blue

silk, five feet six inches fly and four feet four inches on the pike; the state coat of arms embroidered on each side with silk of appropriate colors and design as prescribed in section 98; the edges trimmed with knotted fringe of yellow silk two and one-half inches wide; the pike nine feet long including spearhead and ferrule; the cord eight feet six inches long with two tassels, and composed of blue and white silk strands intermixed.

2. Service flags may be of bunting or other material, of such size as may be required, and the coat of arms represented otherwise than by embroidery, all conforming to proportionate specifications of subsection 1.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 112.

AN ACT to create section 4470n of the statutes, relating to sales of domestic animals, and providing a penalty.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is added to the statutes a new section to read: Section 4470n. Any person, who shall by himself, his servant or agent, or as the servant, agent or officer of any person, firm or corporation, sell or barter or cause to be sold or bartered any domestic animal and shall represent, or cause to be represented that such animal is a pure bred animal, when in fact such animal is not registered, or entitled to registry in any pure breed registry maintained for such animals; or who shall knowingly utter, pass or deliver to any person as true, any false, fraudulent or altered pedigree, shall be punished by a fine not exceeding one thousand dollars or by imprisonment in the county jail not more than one year.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.
