CHAPTER 474.

AN ACT to create subsection 4 of section 496c of the statutes, relating to the establishing of a teachers' training course in free high schools.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is added to section 496c of the statutes a new subsection to read: (Section 496c) 4. Any board having charge of a free high school, or of a high school having a course of study equivalent to the course of study prescribed by the state superintendent for free high schools, in counties where county training schools or joint county training schools have not been established, may establish and maintain in connection with such high school a teachers' training course, which shall be especially approved by the state superintendent as to subjects required to be taught, and the qualifications of teachers in such course.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 475.

AN ACT to amend section 165b and subdivision (c) of subsection 5 of section 170 of the statutes, relating to the school library department in the office of the state superintendent of public instruction, and making an appropriation therefor.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section 165b and subdivision (c) of subsection 5 of section 170 of the statutes are amended to read: Section 165b. The state superintendent may appoint a chief clerk, who shall, under his direction, have charge of the books and correspondence of the office, and who shall render such other assistance as the superintendent may direct. He may also appoint a library clerk, who shall, under his direction, aid in promoting the establishment, maintenance and control of school libraries; *an assistant library clerk who shall aid the library clerk in discharging the duties of his position, especially the office duties pertaining thereto, and who shall have had the library training represented by graduation from a regular library school or its equivalent;* an index and filing clerk and a person as clerk and stenographer.

All such appointments shall be made by writing filed in the office of the secretary of state.

(Section 170.) 5. (c) The inspector of free high schools, twenty-five hundred dollars; the chief clerk, twenty-two hundred fifty dollars; the library clerk, eighteen hundred dollars; *assistant library clerk, initial salary, nine hundred dollars, with an increase, at the discretion of the state superintendent and on the basis of increased efficiency, of not to exceed one hundred dollars per annum in any one year, the maximum salary thus reached not to exceed twelve hundred dollars per annum*; three clerks and stenographer, nine hundred dollars each; an index, filing, diploma and certificate clerk, twelve hundred dollars; the mailing clerk, one thousand dollars. The inspector of free high schools shall be reimbursed his actual and necessary expenses incurred in the performance of his duty; and his salary and expenses shall be paid upon the certificate of the state superintendent, from the appropriation made for free high schools. *The assistant library clerk shall be reimbursed the actual and necessary traveling expenses incurred by such clerk in the performance of his or her duties, upon the certification of the state superintendent, not, however, to exceed one hundred dollars in any one year.*

CHAPTER 476.

AN ACT to create sections 4568m and 4568n of the statutes, relating to frauds or attempted frauds commonly called confidence games and defining certain procedure therefor.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There are added to the statutes two new sections to read: Section 4568m. Every person who shall obtain, or attempt to obtain, from any other person or persons, any money or property, by means or by use of any false or bogus checks, or by any other means, instrument or device, commonly called the confidence game, shall be punished, if the money or property so obtained, or attempted to be obtained, shall exceed the value of five hundred dollars, by imprisonment in the state prison not less than one year nor more than ten years, and if the money or property so obtained, or attempted to be obtained, shall have a value of less than five hundred dollars, by imprisonment in the
