CHAPTER 432.

AN ACT to amend section 172—37 of the statutes, making appropriations for the commissioners of the public lands.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section 172—37 of the statutes, is amended to read: Section 172—37. 1. There is annually appropriated on July first, such sums as may be necessary payable from any moneys in the general fund, not otherwise appropriated, for the commissioners of the public lands to carry into effect the provisions of section 1042j.

2. There is annually appropriated, beginning July 1, * * * 1915, * * * *four thousand two hundred fifty-five* dollars, payable from any moneys in the general fund not otherwise appropriated, for the commissioners of the public lands to carry into effect the powers, duties and functions provided by law for such commissioners.

* * *

SECTION 2. Any unexpended balance of the appropriation provided in subsection 2 of section 172—37 remaining at the close of business on June 30, 1915, shall revert to the general fund.

SECTION 3. This act shall take effect as of July 1, 1915.

CHAPTER 433.

AN ACT to authorize Frank J. Cabot, Jr., and Harold Cabot, doing business as Cabot Brothers, their heirs or assigns, to construct and maintain a dock or pier in the waters of Sturgeon Bay in Door County.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Frank J. Cabot, Jr. and Harold Cabot, doing business as Cabot Brothers, their heirs or assigns, are hereby authorized and empowered to erect, construct and maintain a dock or pier extending into the waters of Sturgeon Bay, with the consent of the property owner, in front of and appurtenant to Block No. 37 according to the assessor's map of the city of Sturgeon Bay, Door County, Wisconsin, as recorded in the office of the register of deeds of said county.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 434.

AN ACT to amend subdivision (1) of section 51.32 of the statutes, relating to fees of life insurance companies.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subdivision (1) of section 51.32 of the statutes is amended to read: (Section 51.32) (1) If such company, corporation or association is organized under the laws of this state, * * * three per centum of its gross income from all sources for the year ending December thirty-first, next prior to said first day of March excepting therefrom income from rents of real estate upon which said company, corporation or association has paid the taxes assessed thereon, and excepting also premiums collected * * * on policies of insurance and contracts for annuities * * * .

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 435.

AN ACT to amend subsection 1 of section 1810 of the statutes, relating to railroad fences.

The people of the State of Wisconsin, represented in Senate and Assembly do enact as follows:

SECTION 1. Subsection 1 of section 1810 of the statutes is amended to read: (Section 1810) 1. Every railroad corporation operating any railroad shall erect and maintain on both sides of any portion of its road (depot grounds excepted) good and sufficient fences of the height of not less than forty-eight inches, with opening or gates or bars therein, suitable and convenient farm crossings of the road for the use of the occupants of the lands adjoining and shall construct and maintain cattle guards at all highways crossings and connect their fences therewith to prevent cattle and other domestic animals from going on such railroad; provided, that the provisions of this section re-
