CHAPTER 571.

AN ACT to repeal subsection 1 and to create subsection 1 of section 172—51 of the statutes, making an appropriation for the board of law examiners.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection 1 of section 172—51 of the statutes is repealed.

SECTION 2. There is added to section 172—51 of the statutes a new subsection to be numbered and to read: (Section 172—51.) 1. There is annually appropriated, beginning July 1, 1915, two thousand one hundred dollars, payable from any moneys in the general fund not otherwise appropriated, for the board of bar examiners to carry into effect the powers, duties and functions provided by law for said board.

SECTION 3. The appropriation made in this act shall be available to pay indebtedness incurred prior to the passage and publication thereof.

SECTION 4. This act shall take effect upon passage and publication.

CHAPTER 572.

AN ACT to amend subsection 6 of section 925m—308 of the statutes, providing for the selection by the common council of cities under the commission form of government from among their number of some one to act as a member of each board and commission in said city, including the board of education.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection 6 of section 925m—308 of the statutes is amended to read: 6. Upon the first Tuesday in May following the reorganization of any city as provided for in sections 925m—301 to 925m—319, inclusive, and annually thereafter, the council shall select from among their number some one to act as a member of each of such boards and commissions, *including the board of education*. Such members so selected shall have all the power and authority vested by law in any other member of such board or commission, and shall serve as a

member thereof so long as he shall remain in office or until the council selects his successor. In cities which have heretofore reorganized under the provisions of sections 925m—301 to 925m—318, inclusive, such selection shall be made at the first regular meeting of the council after the passage and publication of this act, and annually thereafter on the first Tuesday of May.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 573.

AN ACT to create section 172—129 of the statutes, relating to the department of engineering of the state of Wisconsin, and making an appropriation therefor.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is added to the statutes a new section to read: Section 172—129. There is annually appropriated, beginning July 1, 1915, eighteen thousand dollars, payable from any moneys in the general fund not otherwise appropriated, for the department of engineering for the state of Wisconsin to be used for payment of salary of the chief engineer and for defraying to the extent applicable such other overhead salaries and expenses as may be incurred in connection with administering the work of the department, and money expended from the fund hereby appropriated shall not be paid by or chargeable to departments, boards or commissions.

SECTION 2. This act shall take effect upon passage and publication.

AN ACT to appropriate a sum of money therein named for the purpose of erecting a monument over the grave of William R. Taylor, former governor of Wisconsin.

SECTION 1. There is appropriated out of any money in the general fund not otherwise appropriated the sum of five hun-
