

tor present they shall by ballot select such candidate and elect a caucus committee of three of their number, who shall give at least five days' notice fixing the time and place, of the next caucus to be held in such town or village. The two candidates for each office at such caucus who receive the greatest number of votes shall be certified by the chairman and clerk of the caucus to the town or village clerk and the names of such candidates shall be placed upon the official ballot by the town or village clerk, unless the candidates receiving the second largest number of votes shall notify in writing the town or village clerk not later than two days after such caucus that his name be not placed upon the ballot.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 27

AN ACT to detach certain territory from the towns of Hayward and Sand Lake, Sawyer county, Wisconsin, and to create the town of Bass Lake.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. All of township forty north, range nine west, all of sections four, five and six, and lots two and three in section one and lot one in section two and lot one in section three in township thirty-nine north, range nine west, are detached from the towns of Hayward and Sand Lake, Sawyer county, Wisconsin, and created and constituted a separate town to be known and designated as the town of Bass Lake.

SECTION 2. On the first Tuesday of April, A. D. 1917, the qualified electors of the said town of Bass Lake shall meet at the town hall of the town of Sand Lake, as constituted before the passage and publication of this act, and shall, by ballot, elect town officers for their town. For the purpose of such election, the qualified electors of such town, assembled at the place aforesaid, shall, between the hours of nine and eleven o'clock in the forenoon of said day, choose one of their number as chairman, two of their number to act as inspectors and one as clerk, and such electors shall, before entering upon their duties as said officers, take and subscribe the usual oath of office, and file the same with their return. The inspectors shall canvass and return the votes cast at such election in all respects as provided by law for inspectors at annual town meetings. The qualified

electors of such town so assembled may vote for all officers to be chosen on said day, and the votes cast for such officers shall be counted, canvassed and returned in the same manner and shall have the same effect as in other annual town meetings; and said electors so assembled shall have full power to make all provisions for the government of such town as are now authorized by statute to be exercised and made at the annual town meeting of any town.

SECTION 3. Notice of such meeting shall be given by the posting of a copy of this act in at least five public places in said town, at least five days before the time of holding such meeting, which notice may be posted in such town by any qualified elector thereof, who shall make a proper affidavit of such posting, and file the same on the day of said town meeting, with the inspectors chosen at such town meeting to conduct the same.

SECTION 4. When such election shall have been held as herein provided, and the town officers required by law elected, and such officers have duly qualified, as required by law, the said town of Bass Lake shall be deemed to be duly organized, and shall possess all the rights, powers and liabilities of other towns in this state.

SECTION 5. The assets and liabilities of the said town of Hayward, as constituted before the passage and publication of this act, acquired or incurred after the day on which the territory hereby detached from said town of Hayward was heretofore detached from the town of Sand Lake by the county board of Sawyer county and attached to the town of Hayward, shall be proportioned to the town of Bass Lake according to the provisions of section 672 of the statutes, and the liability, if any, so proportioned and the credits and assets, if any, so proportioned, shall be paid according to said section 672 of the statutes.

SECTION 6. The assets and liabilities of the said town of Sand Lake, as constituted before the passage and publication of this act, shall be proportioned to the town of Bass Lake according to the provisions of section 672 of the statutes, and the liability, if any, so proportioned and the credits and assets, if any, so proportioned, shall be paid according to said section 672 of the statutes.

SECTION 7. On the second Tuesday of May, 1917, at ten o'clock in the forenoon, the town boards of the said towns of Hayward, Sand Lake and Bass Lake shall meet at the office of the town clerk of the town of Bass Lake for the purpose of making a settlement between the said towns according to the provisions of this act; and at such meeting, or at any subsequent or adjourned meeting, held by said town boards, any three of the

supervisors shall have full power and authority to send for any persons, books, papers and records necessarily involved in the settlement between said towns. The town clerk of the town of Sand Lake shall be and act as clerk of such joint meeting, and the town clerk of the towns of Hayward and Bass Lake shall be present and assist. Sufficient duplicates or copies of all proceedings had shall be made in order that each town may have at least one copy for the use and information of the town clerk and town board thereof. Each town shall be chargeable with the expense and for the services and per diem of its own officers only.

SECTION 8. This act shall take effect upon passage and publication.

CHAPTER 28

AN ACT to amend sections 1492e—15 and 1492e—16 of the statutes, relating to the board of veterinary examiners.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section 1492e—15 of the statutes is amended to read: Section 1492e—15. A person shall be deemed to be engaged in the practice of veterinary medicine and surgery who shall ask or receive directly or indirectly any pay, or compensation for the treatment of any domestic animals, also menageric animals or any person who shall advertise or hold himself out to the public as a veterinary physician, surgeon or specialist or who shall use the title of "doctor" or who shall append to his name the letters V. S., M. D., D. V. S., or M. D. V., *except that non-graduate license shall read licensed non-graduate veterinarian.*

SECTION 2. Section 1492e—16 of the statutes is amended to read: Section 1492e—16. But nothing in this act contained shall be construed so as to prevent a bona fide student in regular attendance at any *recognized* veterinary college * * * from practicing veterinary medicine and surgery * * * *not more than eighteen months under the direct supervision of a regular licensed graduate veterinarian.*

SECTION 4. This act shall take effect upon passage and publication.
