### CHAPTER 19.

AN ACT to repeal subsections (5), (6) and (8) of section 20.15 and to create a new subsection of section 20.15 of the statutes, relating to the Grand Army of the Republic, and making an appropriation.

*The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Subsections (5), (6) and (8) of section 20.15 of the statutes are repealed.

SECTION 2. There is added to section 20.15 of the statutes a new subsection to be numbered and to read: (20.15) (5) To the Wisconsin Department of the Grand Army of the Republic, on May 1, 1919, not to exceed five hundred dollars, and annually, beginning July 1, 1919, not to exceed one thousand dollars, for necessary expenses of the annual encampment thereof, to be expended only upon the certification by the commander thereof to the secretary of state.

SECTION 3. This act shall take effect upon passage and publication.

### CHAPTER 20.

AN ACT to appropriate certain sums of money herein mentioned, for the purpose of paying the expenses incurred by the joint committee of the legislature, appointed pursuant to the provisions of joint resolution No. 3, S. of the first special session of 1918, to recommend a drainage bill to the 1919 session of the legislature.

*The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. For the purpose of paying the expenses incurred by the joint committee of the legislature, appointed pursuant to

the provisions of joint resolution No. 3, S. of the first special session of 1918, to recommend a drainage bill to the 1919 session of the legislature, there is appropriated from the general fund the following sums:

### CHAPTER 21.

SECTION 1. Paragraph (g) of subsection (7) of section 20.01 of the statutes is amended to read: (20.01) (7) (g) \* \* \* *Twelve* messengers, each two dollars and fifty cents per day.

### CHAPTER 22.

AN ACT to appoint a committee to welcome Wisconsin soldiers and to create subsection (8) of section 20.02 of the statutes, and making an appropriation therefor.

*The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. The governor is hereby authorized to appoint a committee, located in the city of New York, to represent the state of Wisconsin in welcoming and aiding Wisconsin soldiers as they return from oversea service.

SECTION 2. A new subsection is added to section 20.02 of the statutes to read: (20.02) (8) To the executive department not to exceed five thousand dollars for carrying out the purposes of
