

(6) The word "person" as used in this section shall include firms, associations and corporations.

(7) Any person violating any of the provisions of this section shall, on conviction thereof, be punished by fine not exceeding five hundred dollars, or by imprisonment not exceeding three months, or by both such fine and imprisonment at the discretion of the court.

SECTION 2. This act shall take effect upon passage and publication.

## CHAPTER 128.

AN ACT to repeal section 39.28 and subsection (1) of section 39.30; to renumber subsections (2), (3) and (4) of section 39.30 to be subsections (1), (2) and (3) of section 39.30; to create a new section to be numbered section 39.28, and to amend sections 39.285, 39.29, 39.30 and 20.23 of the statutes, relating to the powers and duties of the state board of teachers' examiners and making an appropriation to the state superintendent of public instruction.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Section 39.28 and subsection (1) of section 39.30 of the statutes are repealed.

SECTION 2. Subsections (2), (3) and (4) of section 39.30 are renumbered to be subsections (1), (2) and (3), respectively, of section 39.30.

SECTION 3. A new section is added to the statutes to be numbered and to read: 39.28 The state superintendent is authorized to conduct an examination annually for all applicants for state certificates at such places as he shall prescribe. He shall determine in what branches of study, in addition to those prescribed by law, the applicant for a limited and for an unlimited state certificate shall be examined, and shall prescribe the rules governing the manner of conducting such examination. He may appoint properly qualified persons to prepare questions for such

examinations, to conduct such examinations, and to report the results thereof.

SECTION 4. Section 39.285 of the statutes is amended to read: 39.285 To entitle an applicant to a limited state certificate \* \* \* *the state superintendent* shall be satisfied \* \* \* that he possesses the requisite scholarship in all the branches of study \* \* \* *prescribed by said superintendent*. To entitle him to an unlimited state certificate \* \* \* *the state superintendent* shall be satisfied \* \* \* that he possesses the requisite scholarship in all of the branches \* \* \* *required for a limited state certificate* and in such others as shall have been prescribed. He shall furnish to \* \* \* *the state superintendent* such evidence of good moral character, experience and success in teaching as \* \* \* *he may require*, and \* \* \* the state superintendent shall issue to him \* \* \* *the grade of certificate to which he is entitled as evidenced by his examination, moral character and success in teaching*. A limited state certificate shall qualify the holder to teach in any public school without further examination for five years from its date unless sooner annulled, but neither a limited state certificate nor a certificate based upon graduation from the elementary course of a normal school shall qualify the holder as principal of a free high school having a four-year course of study. An unlimited state certificate shall qualify the holder to teach in any public school without further examination or as principal of a free high school having a four-year course of study until annulled.

Section 39.29 of the statutes is amended to read as follows: 39.29 (1) The holder of a diploma granted by an incorporated college, university, or normal school other than the University of Wisconsin, a Wisconsin state normal school, or Stout institute, who shall present satisfactory evidence to the state \* \* \* *superintendent* of having completed a course fully and fairly equivalent to the corresponding course in the above named institutions and of having given to psychology and pedagogy at least as much study as is required in this state of candidates for a life certificate and who shall also furnish such evidence as to moral character as the said \* \* \* *superintendent* may require shall be issued such license by the state superintendent \* \* \* *as he shall consider suitable to the applicant's attainments*. Upon presentation of satisfactory evidence of successful

teaching for one year in the public schools of the state, such license \* \* \* may be renewed for one year by the state superintendent. Upon the presentation of satisfactory evidence of good moral character and two years of successful teaching in the public schools in this state after graduation the holder of such diploma shall be entitled to receive from the state superintendent an unlimited state certificate \* \* \*.

(2) (a) All persons who apply to the state \* \* \* superintendent for a state license on the basis of work done in, or graduation from, an institution located outside the state of Wisconsin, shall pay a fee of two dollars for the examination of their papers, records and credentials. *All such persons before receiving second licenses or subsequent licenses shall pay an additional fee of two dollars before such licenses shall be issued.* All such persons, before receiving a state certificate, shall pay an additional fee of two dollars before a state certificate shall be issued.

(b) *All persons who apply to the state superintendent for a second state license or subsequent licenses on the basis of work done in or graduation from the University of Wisconsin, a Wisconsin state normal school, Stout institute, or any other institution located inside the state of Wisconsin shall pay a fee of one dollar for the examination of their papers, records and credentials before such license shall be issued. All such persons before receiving a state certificate shall pay an additional fee of one dollar before a state certificate shall be issued.*

(c) *All persons applying for a limited state certificate or unlimited state certificate upon examination shall pay a fee of one dollar for the examination of their papers, records and credentials.*

\* \* \* (d) The fee for the examination of the papers \* \* \* and the fee for the issuance of \* \* \* state licenses and certificates shall be payable to the state superintendent of public instruction.

Section 39.30 is amended to read as follows: 39.30 (1) The state superintendent may \* \* \* grant a special license or a certificate legally qualifying the holder to teach such special branch or branches in the public schools, as may be named on the face of the license or certificate for such period of time as may be specified in the license or certificate.

(2) \* \* \* *The state superintendent may grant to an applicant \* \* \* a limited special license for not more than one year qualifying him to teach one or more special branches in the public schools, said license being limited to one particular school or district to be named in the license, said license to be null and void in any other school or district.*

(3) The state superintendent is authorized and empowered to issue state licenses or certificates to persons who are engaged in supervising work in the public schools or teaching in colleges, normal schools or other educational institutions in the state supported by the public funds and who are under existing statutes otherwise legally qualified. \* \* \*

Section 20.23 is amended to read as follows: 20.23 \* \* \*  
All moneys received by each and every person for or in behalf of said superintendent under the provisions of subsection (2) of section 39.29 shall be paid within one week after receipt into the general fund, and are appropriated therefrom and added to \* \* \* *the appropriation of the state superintendent to be used in carrying out his functions in the certification of teachers.* \* \* \*

SECTION 5. This act shall take effect upon passage and publication.

## CHAPTER 129.

AN ACT to create subsection (15) of section 20.20 of the statutes, relating to the reforestation fund validating payments made from the "forest reserve fund" and making an appropriation.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. A new subsection is added to section 20.20 of the statutes to read: (20.20) (15) There is created a fund in the state treasury to be known as the "reforestation fund". All balances now existing in the fund carried on the books of the secretary of state and state treasurer as the forest reserve fund
