CHAPTER 168.

AN ACT to amend subsection (14) of section 210.05 of the statutes, relating to the limit of policies of life insurance in the state life fund.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection (14) of section 210.05 of the statutes is amended to read: (210.05) (14) Policies of life insurance may be issued upon being approved by the commissioner of insurance and the state board of health; but no policy or policies shall be issued * * * *on any one risk exceeding in amount one-half of one per cent of the total amount of insurance in force.*

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 169.

AN ACT to amend paragraph (b) of subsection (7) of section 67.05 of the statutes, relating to the issuance of bonds for the erection, replacement or major repair of bridges.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Paragraph (b) of subsection (7) of section 67.05 of the statutes is amended to read: (67.05) (7) (b) An initial resolution adopted by the common council of any city for an issue of bonds for street improvements, school purposes, waterworks, lighting works, gasworks, hospitals, harbor improvements, sewerage, parks and public grounds, street railway property, * * * apparatus or equipment for fire protection, *or the erection, replacement or major repair of bridges*, or an initial resolution adopted by the common council of any city of the first class for an issue of bonds for purposes specifically enumerated in subsection (5) need not be submitted to the electors as provided in subsection (5), unless within thirty days after the recording thereof there shall be filed in the office of the city clerk a petition requesting such submission, signed by electors numbering at least ten per cent of the votes cast for governor in the city at the last general election. If such petition be filed, proceedings shall be had as provided by subsection (5). But any such resolution may, in the discretion of the city council, by separate recorded resolution, be submitted to popular vote without waiting for the filing of said petition.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 170.

AN ACT to create section 1.035 of the statutes, relating to the establishment of the "Upper Mississippi Wild Life and Fish Refuge".

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. A new section is added to the statutes to read: 1.035 (1) The state of Wisconsin hereby consents that the government of the United States may acquire in this state, in any manner, such areas of land, or of land and water, as the United States may deem necessary for the establishment of the "Upper Mississippi River Wild Life and Fish Refuge", in accordance
