CHAPTER 178.

AN ACT to amend section 61.35 of the statutes relating to village planning.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section 61.35 of the statutes is amended to read:
61.35 The provisions of section 62.23 shall apply to * * * villages, * * * and the powers and duties conferred and imposed by said section upon mayors, councils and specified city officials are hereby conferred upon presidents, village boards, and village officials performing duties similar to the duties of such specified city officials, respectively. Any ordinance or resolution heretofore passed by any village board under the provisions of section 61.35 shall be and remain in full force and effect until repealed or amended by such village board; in case the village has no official paper, the notice specified in paragraph (c) of subsection (5) of section 62.23 shall be posted in three public places in said village at least ten days prior to the date of hearing therein specified.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 179.

AN ACT to create subsection (6) of section 29.60 of the statutes, relating to bounty on wild animals.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. A new subsection is added to section 29.60 of the

statutes to read: (29.60) (6) The county board may authorize the payment of an additional bounty for the killing of any animal for which the state pays a bounty under this section, not to exceed such state bounty.

CHAPTER 180.

AN ACT appropriating a sum of money specified herein to the judiciary committee of the assembly for the conduct of the investigation directed by resolution No. 30, A.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is appropriated from the general fund to the judiciary committee of the assembly a sum not exceeding one thousand five hundred dollars to pay expenses incurred by said committee for the services of a reporter, witness fees, and other necessary expenses in the conduct of the investigation which said committee has been directed to make by resolution No. 30, A., involving charges against Circuit Judge E. B. Belden. Expenditures shall be made upon vouchers signed by the chairman or acting chairman of the assembly judiciary committee.

SECTION 2. This act shall take effect upon passage and publication.
