**CHAPTER 281.**

AN ACT to amend section 6.26 of the statutes, relating to number of sample ballots for towns, villages and cities.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Section 6.26 of the statutes is amended to read: 6.26 There shall be printed, in the manner hereinbefore provided, a sufficient number of ballots, not to exceed seventy-five ballots for each fifty votes cast at the second last preceding general election, to be used at each election precinct in the county. At the time the official ballots are printed, unofficial sample ballots shall be printed upon tinted or colored paper, and in the same form as the official ballots, to an amount not exceeding \* \* \* *one-fourth* of the official ballots for the county and \* \* \* *ten* per cent of the sample ballots shall be held by such clerk at his office and shall be distributed to voters upon application therefor. \* \* \* *Ninety* per cent of the sample ballots shall be sent to the election booths in proportion to the number of votes cast at the preceding election in the district where the booths are located, to be there distributed by the inspectors of election to voters upon application therefor. Such ballots shall be paid for in the same manner that the official ballots shall be paid for, without additional charge for composition.

SECTION 2. This act shall take effect upon passage and publication.

**CHAPTER 282.**

AN ACT to create subsection (38) of section 70.11 of the statutes, relating to the exemption from taxation of vessels from other states laid up for repairs in Wisconsin ports.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. A new subsection is added to section 70.11 of the statutes to read: (70.11) (38) All vessels, boats, barges or other

water craft belonging to inhabitants of states other than Wisconsin and laid up for repairs in Wisconsin ports.

SECTION 2. This act shall take effect upon passage and publication.

### CHAPTER 283.

AN ACT to create paragraph (h) of subsection (1) of section 29.56 of the statutes, relating to a wild life refuge in Bayfield county.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. A new paragraph is added to subsection (1) of section 29.56 of the statutes to read: (29.56) (1) (h) All of section 5 and in section 4,—(1) the west 282 feet of the northwest quarter of the northwest quarter, an area of 4 acres, and (2) the southwest quarter of the southwest quarter, an area of approximately 3.37 acres, in township 49 north, range 4 west, located in the town of Bayview in Bayfield county.

SECTION 2. This act shall take effect upon passage and publication.

### CHAPTER 284.

AN ACT to create paragraph (m) of subsection (1) of section 16.33 of the statutes, relating to staff in the criminal department of the office of the district attorney in certain counties.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. A new paragraph is added to subsection (1) of section 16.33 of the statutes, to read: (16.33) (1) (m) Assistants and all members of the staff in the criminal department of the office of the district attorney, except employes engaged in clerical and stenographic work.

SECTION 2. This act shall take effect upon passage and publication.
