**CHAPTER 75.**

AN ACT to create subsection (5) of section 311.10 of the statutes, providing for the distribution of assets coming to an estate after regular administration has terminated.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. A new subsection is added to section 311.10 of the statutes to be numbered and to read:

(311.10) (5) The procedure provided by this section shall be available, in case the general administration of the estate of a decedent has been closed and thereafter assets have come to said estate or shall be found belonging to it, for the purpose of receiving such assets and making disposition thereof.

SECTION 2. This act shall take effect upon passage and publication.

**CHAPTER 76.**

AN ACT to amend subsection (6) of section 48.33 of the statutes, providing an allowance under the dependent children's aid law for burial expenses of a minor child.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Subsection (6) of section 48.33 of the statutes is amended to read: (48.33) (6) The aid granted shall be sufficient to enable the mother or stepmother having the care and custody of such children to care properly for the children. The amount to be granted shall be determined by a budget for each family in which all possible income as well as expenses shall be considered. Such family budget shall be based on a standard budget, which shall be worked out annually by the judge of the court administering such aid and the county board or a committee of the board designated by it; provided, that if the county board shall not take action in such matter such standard budget shall be worked out by the judge alone. Medical and dental aid may be granted to minor

children, the mother or the incapacitated father, as necessary. *In the case of the death of a minor child not to exceed one hundred dollars shall be allowed to cover the burial expenses of such child.* Aid pursuant to this section shall be the only form of public assistance granted to the family, except medical and dental aid, and no aid shall continue longer than one year without reinvestigation.

SECTION 2. This act shall take effect upon passage and publication.

### CHAPTER 77.

AN ACT to create subsection (9b) of section 59.08 of the statutes, relating to a closing hour for places where soft drinks are sold. *The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. A new subsection is added to section 59.08 of the statutes to read: (59.08) (9b) Enact ordinances providing for a specified closing hour for places where soft drinks are sold. Ordinances, by-laws, or rules and regulations enacted by a county board under this subsection shall not apply to any city or village in such county which has or may hereafter by ordinance regulate and control places where soft drinks are sold.

SECTION 2. This act shall take effect upon passage and publication.

### CHAPTER 78.

AN ACT to amend section 289.43 of the statutes, relating to innkeepers' liens, and ex-service men's exemptions therefrom. *The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Section 289.43 of the statutes is amended to read: 289.43 Every innkeeper, hotel keeper, and every keeper of a boarding house or lodging house, whether individual, copartnership, or corporation, shall have a lien upon and may retain the possession
