CHAPTER 95.

AN ACT to renumber section 61.31 of the statutes to be subsection (1) of section 61.31, and to create subsection (2) of section 61.31, relating to the powers of village police officers.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section 61.31 of the statutes is renumbered to be subsection (1) of section 61.31 of the statutes.

SECTION 2. Subsection (2) of section 61.31 of the statutes is created to read:

(61.31) (2) Every village police officer shall possess the powers, enjoy the privileges, and be subject to the liabilities conferred and imposed by law upon village marshals.

SECTION 3. This act shall take effect upon passage and publication.

CHAPTER 96.

AN ACT to amend 85.67 (5) of the statutes, relating to brakes on motor vehicle drawn trailers, semitrailers and other similar trailers.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Subsection (5) of section 85.67 of the statutes is amended to read:

(85.67) (5) Every trailer, * * * semitrailer or other vehicle manufactured after January 1, 1942, having * * * a

gross weight of * * * 3,000 pounds or more *when drawn or pulled upon a highway* shall be equipped with brakes * * * *adequate to control the movement of and to stop and to hold such vehicle and of design approved by the motor vehicle department, excepting trailers owned by farmers when transporting agricultural products produced on the owner's farm, supplies or equipment back to the farm of the owner of the trailer, and except disabled vehicles being towed to a place of repair and except passenger automobiles and trucks while being towed.* All such brakes shall be maintained in good working order and shall be considered efficient if the vehicle can be stopped under normal conditions within 50 feet when traveling at a rate of speed of 20 miles per hour.

CHAPTER 97.

AN ACT to amend 70.46 (5) of the statutes, relating to members of the board of review.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Subsection (5) of section 70.46 of the statutes is amended to read:

(70.46) (5) The members of such board * * *, *except members who are full time employes or officers of the town, village or city,* shall receive such compensation as shall be fixed by resolution or ordinance of the town board, village board, or common council. * * *

SECTION 2. This act shall take effect upon passage and publication.
