

or from the county at large. They shall have a demonstrated and recognized knowledge of and interest in public welfare. They shall serve for such terms and receive such compensation as shall be fixed by the county board of supervisors.

SECTION 3. 58.55 (10) of the statutes is repealed and re-created to read:

58.55 (10) To administer child welfare service under and subject to the provisions of section 48.315, thereby administering the functions otherwise administered by county children's boards and licensed child welfare agencies.

#### CHAPTER 294.

AN ACT to amend 70.425 (1) of the statutes, relating to the occupational tax on owners of domestic mink.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

70.425 (1) of the statutes is amended to read:

70.425 (1) There is imposed an annual occupational tax on every person, firm or corporation owning or operating any domestic mink farm, computed on the basis of \* \* \* \$5 for each such farm, which tax shall be in addition to all other taxes.

#### CHAPTER 295.

AN ACT to authorize the conservation commission to dispose of certain park lands to the village of Cassville.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

The conservation commission is empowered and authorized to sell or otherwise dispose of certain lands located in the Nelson Dewey Memorial State Park and west of the Chicago, Burling-

ton and Quincy Railroad therein to the village of Cassville upon such terms and conditions as may be mutually agreed upon and to execute and deliver the necessary instruments for the transfer of the title thereto. The proceeds of the sale of such property shall be paid into the state park fund as provided by section 27.01 (2) (d).

### CHAPTER 296.

AN ACT to create 15.85 of the statutes, relating to the Governor's commission on human rights.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

15.85 of the statutes is created to read:

15.85 GOVERNOR'S COMMISSION ON HUMAN RIGHTS. There is created the Governor's commission on human rights to consist of not to exceed 35 members who shall be appointed by the governor for terms of 3 years each without the advice or consent of the senate. Members shall be appointed from the entire state and shall be representative of all races, creeds, groups, organizations and fields of endeavor. They shall receive no compensation for their services. It shall be the duty of the commission to disseminate information and to attempt by means of discussion as well as other proper means to educate the people of the state to a greater understanding, appreciation and practice of tolerance, to the end that Wisconsin will be a better place in which to live.
