### CHAPTER 436.

AN ACT relating to the powers and duties of the state centennial committee, and making an appropriation.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. The powers, duties and functions of the state centennial committee as provided by chapter 162, laws of 1947, include the power to contract for the manufacture, preparation or furnishing of souvenirs or other articles; to purchase for sale and sell the same to the public at such price as the committee may determine; to charge admissions or fees for such observances, exhibitions, games, contests or other functions or activities as the committee may deem advisable; to receive and assume custody of any products or other personal property and to act as the agents of the owners in the disposition of the same. The mention of any specific line of activity herein shall in no manner limit the powers of the committee, but it shall have authority to do all things necessary for an adequate centennial observance in the fields of agriculture, education, industry, recreation, or otherwise. The committee shall not incur any obligations beyond the amounts appropriated to it by law.

SECTION 2. All amounts received by the committee for and on account of others shall be accounted for to them as per agreement. Receipts by the committee on its own account shall be paid within one week after receipt into the general fund of the state treasury and are appropriated therefrom to the committee and added to the appropriation made in section 4 of chapter 162, laws of 1947.

SECTION 3. The provisions of section 15.14 of the statutes, relating to quarterly estimates of expenditures and releases of appropriations by the director of budget and accounts, shall not apply to expenditures from appropriations made in chapter

162, laws of 1947 or in this act to the state centennial committee. Disbursements from these appropriations shall be made as determined by the committee. An itemized record shall be kept of all disbursements showing the date, amount and purpose thereof, and the person to whom paid with his address.

### CHAPTER 437.

AN ACT to amend 114.151 and to create 114.11 (4) of the statutes, relating to airports and the powers of municipalities.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. 114.11 (4) of the statutes is created to read:

114.11 (4) The governing body of any county, city, village or town is authorized to appropriate money to any town, city, village or other county, for the operation, improvement or acquisition of an airport by such town, city, village or other county or any combination of such municipalities.

SECTION 2. 114.151 of the statutes is amended to read:

114.151 All powers conferred upon any county, city, village or town by sections 114.11 to 114.15, relating to the acquisition, establishment, construction, ownership, control, lease, equipment, improvement, maintenance, operation and regulation of airports or landing fields may be exercised by any 2 or more municipalities in the establishment, acquisition, equipment and operation of joint airports or landing fields. *The governing body of any county, city, village or town participating in the ownership or operation of a joint airport as provided in this section may by resolution withdraw from such joint operation or control and may relinquish its interest in the airport.*
