CHAPTER 591.

AN ACT to amend 93.07 (18) (c) of the statutes, relating to vehicles used on the state fair grounds in racing competition.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

93.07 (18) (c) of the statutes is amended to read:

93.07 (18) (c) Every vehicle propelled by gasoline or other similar motive power, used on the state fair grounds in racing competition or practice therefor (except during the annual state fair and except at other times between 8 o'clock in the morning and * * * 10 o'clock in the evening) shall be equipped with a muffler which, at all times, shall be in good working condition sufficient to prevent excessive or unusual noise. It shall be unlawful to operate, or for the department to permit to be operated, on the state fair grounds in racing competition or practice therefor (except during the annual state fair and except at other times between 8 o'clock in the morning and * * * 10 o'clock in the evening) any such vehicle, so propelled by gasoline or other similar motive power, with the muffler off or cutout open.

CHAPTER 592.

AN ACT to create 20.25 (5) and 40.21 (2b) of the statutes, relating to high school tuition for children in foster homes and making an appropriation.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Section 1. 20.25 (5) of the statutes is created to read:

20.25 (5) Annually, beginning July 1, 1947, \$20,000 for payment of the legal tuition of children in foster homes attending high school as provided in section 40.21 (2b).

Section 2. 40.21 (2b) of the statutes is created to read:

40.21 (2b) FOSTER HOMES. The provisions of subsection (2a) shall also apply to children in duly licensed foster homes attending high school in the locality in which such duly licensed

foster home is located, except that the tuition in such cases shall be paid out of the appropriation made by section 20.25 (5). If in any year the claims for tuition under this section shall exceed the amount appropriated by section 20.25 (5), the state superintendent shall equitably prorate the amount available among the several school districts making claims.

CHAPTER 593.

AN ACT to amend 85.82 of the statutes, relating to licensing of taxicab operators and taxicabs.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

85.82 of the statutes is amended to read:

85.82 MUNICIPALITIES MAY LICENSE TAXICAB OP-ERATORS AND TAXICABS. The council of every city and every village board may regulate and license chauffeurs and operators of taxicabs used for hire and may also regulate and license the taxicab business by licensing each taxicab used for hire and may require that no * * * person shall operate any motor vehicle for hire upon the highways of such city or village. unless such person is licensed as a chauffeur and operator and unless such taxicab business is licensed by the licensing of each taxicab, and may revoke any such license when in their judgment the public safety requires such revocation. Any person licensed by any city or village as a chauffeur and operator shall not be required to procure either a chauffeur's and operator's license or a taxicab license in any other municipality * * * for the purpose of carrying taxicab passengers for hire from one municipality to another, but this exception shall not permit such chauffeur or operator to operate a taxicab wholly within the limits of any municipality in which such chauffeur or operator is not licensed.
