**CHAPTER 373**

AN ACT to amend 201.25 (1) (hk) of the statutes, relating to investments by domestic insurance corporations.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

201.25 (1) (hk) of the statutes is amended to read:

201.25 (1) (hk) In equipment securities or in certificates of any equipment trust evidencing rights to receive partial payments agreed to be made upon any contract of leasing or conditional sale \* \* \* the issue of which has been approved by the proper public authority, if such approval was required by law at the time of issue, if such lessee or conditional vendee is a solvent company organized under the laws of the United States or of any state thereof, or of the Dominion of Canada or of any province thereof, if the net earnings of such company for a period of 3 fiscal years next preceding the date of investment as defined and applied pursuant to par. (fg) shall have averaged per year not less than 1-1/2 times its average annual fixed charges applicable to such period, as defined in par. (fg), and if the company issuing such securities has not defaulted in the payment of principal or interest upon any of its bonds, or other evidences of indebtedness at any time during 5 years prior to the date of investment. \* \* \*
