CHAPTER 247

AN ACT to amend and revise chapter 20 and to make divers other changes in the statutes and session laws, relating to state finances and appropriations, constituting the miscellaneous segregated funds budget bill of the 1965 legislature, and making appropriations.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. 20.005 (2) of the statutes, as it relates to the miscellaneous segregated funds, is created to read:

20.005 (2) PROGRAM APPROPRIATIONS. There are appropriated to each agency named in par. (a) the amounts shown therein for the programs and other purposes indicated. All appropriations are authorized from the funds indicated. The letter abbreviations shown designating the type of appropriation apply to both years in the schedule unless otherwise indicated.

(a) The following tabulation is an alphabetical arrangement by state agency of miscellaneous segregated fund appropriations made by this act (1965), or of anticipated expenditures of miscellaneous segregated fund program revenue appropriations made by this act (1965).

**SECTION 2.** 20.270 (1) (u) of the statutes is created to read:

20.270 (1) (u) *Emergency disaster fund.* All moneys in the emergency disaster fund under s. 25.39 to be used on a matching basis with the federal government to purchase equipment for emergency disaster training and in case of natural or man-made emergency. The moneys appropriated by this paragraph shall not become available until released by the governor at such times and in such amounts as he determines.

**SECTION 3.** 20.270 (71) and (72) of the statutes are repealed.

**SECTION 4.** 20.282 of the statutes is repealed and recreated to read:

20.282 CONSERVATION WARDEN PENSION FUND. There is appropriated from the conservation warden pension fund to the board of trustees of said fund for the following program:

(1) OPERATIONS AND BENEFITS. (u) *General program operations.* A sum sufficient to carry out the purposes of s. 23.14.

**SECTION 5.** 20.365 (81) of the statutes is renumbered 20.365 (1) (u).

**SECTION 6.** 20.385 (2) of the statutes is repealed and recreated to read:

20.385 (2) SEGREGATED FUNDS. (u) *General program supplementation.* A sum sufficient from any state fund other than the general fund to be used to supplement appropriations made from such fund, as provided in s. 14.72. The governor may under this paragraph allot sums not in excess of \$1,000 to any department when necessary, without a meeting of the board. All supplements made pursuant to this subsection to an ap-

appropriation shall be certified to the department of administration, and expenditures therefrom shall be shown in the state budget report as an additional cost of the department or commission and program for which such supplements were made.

SECTION 7. 20.408 (1) (u) of the statutes is created to read:

20.408 (1) (u) *Premium payments.* All moneys received from group life and health insurance contributions pursuant to s. 66.919 for payments by the board to insurance carriers.

SECTION 8. 20.440 (7) of the statutes is created to read:

20.440 (7) **SEGREGATED FUNDS.** (u) *Death benefit fund.* All moneys paid into the death benefit fund under s. 102.49, to carry out the purposes of said fund.

(v) *Injuries indemnity fund.* All moneys paid into the injuries indemnity fund under s. 102.59, to carry out the purposes of said fund.

SECTION 9. 20.440 (71) and (72) of the statutes are repealed.

SECTION 10. 20.440 (73), (74), (75) and (76) (a) (intro. par.) and 1, 2, 3 and 4 and (b) to (i) of the statutes are renumbered 20.440 (1) (u), (v), (w) and (x) 1 (intro. par.), a, b, c and d and 2 to 9, respectively, and, as renumbered, 20.440 (1) (x) (title) of the statutes is amended to read:

20.440 (1) (x) *Employment security building projects.*

SECTION 11. 20.460 (3) (v), (4) (v) and (7) of the statutes are created to read:

20.460 (3) (v) *Insurance losses.* The balance of moneys received under ss. 210.02 and 210.04, after the appropriation for administrative expenses, for the payment of insurance losses. Payments to the state of Wisconsin investment board pursuant to s. 20.480 (1), payments to the general fund pursuant to s. 200.17 (4), loss adjustment expenses and fire rating bureau dues shall be charged directly to this subsection.

(4) (v) *Operations and benefits.* The balance of moneys received under s. 210.05, after the appropriation for administrative expenses, to carry out the purposes of said fund. Payments to the state of Wisconsin investment board pursuant to s. 20.480 (1) for payments for medical examinations and inspection reports shall be charged directly to this subsection.

(7) **WORKMEN'S COMPENSATION SECURITY FUNDS.** (u) *Mutual workmen's compensation security fund.* All moneys paid into the mutual workmen's compensation security fund under s. 102.65 (4), to carry out the purposes of said fund as provided in s. 102.65.

(v) *Reciprocal workmen's compensation security fund.* All moneys paid into the reciprocal workmen's compensation security fund under s. 102.65 (6), to carry out the purposes of said fund as provided in s. 102.65.

(w) *Stock workmen's compensation security fund.* All moneys paid into the stock workmen's compensation security fund under s. 102.65 (2), to carry out the purposes of said fund as provided in s. 102.65.

SECTION 12. 20.460 (71) to (75) of the statutes are repealed.

SECTION 13. 20.480 (70) of the statutes is repealed.

SECTION 14. 20.500 (71), (72), (73) and (74) of the statutes are renumbered 20.500 (1) (u), (v), (w) and (x), respectively.

SECTION 15. 20.548 (1) (u) of the statutes is created to read:

20.548 (1) (u) *Fund operations*. All moneys received from contributions for Milwaukee teachers annuities and retirement for payments by the board under s. 38.24.

SECTION 16. 20.551 (2) of the statutes is repealed.

SECTION 17. 20.551 (7) of the statutes is renumbered 20.550 (11).

SECTION 18. 20.640 (1) (u) of the statutes is created to read:

20.640 (1) (u) *Payment to U.S. treasury*. All moneys received from social security contributions pursuant to s. 66.99 for payment to the secretary of the U.S. treasury under s. 66.99 (9).

SECTION 19. 20.670 (9) (u) of the statutes is created to read:

20.670 (9) (u) *Construction*. A sum sufficient from the state building trust fund for the payment of rentals by the department and for permanent improvements and the acquisition of all equipment therefor, remodeling and purchase of land under s. 46.035 on projects designated by the state building commission when the projects are initiated.

SECTION 20. 20.670 (71) to (75) of the statutes are repealed.

SECTION 21. 20.760 (9) (u) of the statutes is created to read:

20.760 (9) (u) *Construction*. A sum sufficient from the state building trust fund for the payment of rentals by the regents and for permanent improvements and the acquisition of all equipment therefor, remodeling and purchase of land under s. 36.06 (6) on projects designated by the state building commission when the projects are initiated.

SECTION 22. 20.7601 of the statutes is repealed.

SECTION 23. 20.810 (1) (u) and (v) of the statutes are created to read:

20.810 (1) (u) *Administration*. From the moneys received by the state teachers retirement system under ss. 42.20 to 42.54, the amounts in the schedule for administration, other than investment expenses, audit charges, and transfers to the state deposit fund established by ch. 34. Any balance lapsing from this allotment shall be credited to the appropriation under par. (v).

(v) *Operations and benefits*. All moneys received under ss. 42.20 to 42.54, after the appropriation for administrative expenses, for operations and benefits, including investment expenses, audit charges, transfers to the state deposit fund established by ch. 34 and the payment of annuities, death benefits and separation benefits as provided in said sections.

SECTION 24. 20.822 of the statutes is repealed and recreated to read:

20.822 TURNPIKE COMMISSION. There is appropriated from the state highway fund to the Wisconsin turnpike commission for the following program:

(1) GENERAL ADMINISTRATION. (u) *General program operations*. As a continuing appropriation the unencumbered balance remaining in s. 20.822 (71), 1963 stats., on June 30, 1965, which shall not be subject to any other laws regulating the use of highway funds, for the purpose of carrying out the duties and functions of the commission. Expenditures shall be made upon vouchers signed by the chairman or secretary of the commission.

SECTION 25. 20.830 (1) (x) and (9) (u), (v), (w) and (x) of the statutes are created to read:

20.830 (1) (x) *University trust fund income.* The amounts in the schedule from trust fund income under s. 36.03.

(9) (u) *Construction.* From the state building trust fund, a sum sufficient for the payment of rentals by the regents and for permanent improvements and the acquisition of all equipment therefor, remodeling and purchase of land under s. 36.06 (6) on projects designated by the state building commission when the projects are initiated.

(v) *Federal funds; physical plant.* All federal matching funds granted to the board of regents shall be deposited in the state building trust fund and are appropriated therefrom to the regents for the construction, remodeling, improvement and revision of the physical plant of the university.

(w) *University trust fund operations.* The amounts in the schedule for university trust fund operations pursuant to s. 36.03.

(x) *University trust fund income.* The amounts in the schedule from trust fund income under s. 36.03.

SECTION 26. 20.8301 of the statutes is repealed.

SECTION 27. 20.840 (2) of the statutes is created to read:

20.840 (2) **LOANS AND AIDS TO VETERANS.** All moneys received in the veterans trust fund for the purposes of said fund. Of this there is allocated for the following purposes:

(u) *Administration of loans and aids to veterans.* The amounts in the schedule for the administration of loans and aids to veterans.

(um) *Veterans loans and aids.* A sum sufficient but not to exceed \$1,500,000 each year for payment of benefits to veterans and their dependents under ch. 45, and for the hospitalization of veterans under s. 45.38 (1).

(v) *Operation of memorial hall.* The amounts in the schedule for the operation of the G.A.R. memorial hall under s. 45.01.

(vm) *Veterans memorial commission.* The amounts in the schedule to reimburse the members of the veterans memorial commission for their actual and necessary expenses incurred in the performance of their duties under s. 45.60.

(w) *Payments to veterans organizations for claims service.* A sum sufficient to pay veterans organizations for claims services as prescribed in s. 45.351.

(wm) *Repairs and improvements to homes for needy veterans.* The unencumbered balance remaining in s. 20.840 (85), 1963 stats., on June 30, 1965, as a continuing appropriation for the repair and improvement of facilities operated in this state by bona fide veterans organizations as homes for the retreat or asylum of needy veterans. Allocations shall be made from this appropriation to bona fide veterans organizations qualifying upon application showing the applicant's eligibility and requirements for an allocation and such other pertinent matters as the department of veterans affairs prescribes.

(x) *Veterans loans.* All moneys received from loans sold to the state of Wisconsin investment board pursuant to s. 25.17 (3) (bg), for additional loans to veterans in accordance with s. 45.352. Loans so sold shall be segregated on the records of the department, and principal collection thereon together with interest received from said loans so sold shall be remitted after the close of each month to the investment board. Not later than 90 days after July 1 and January 1 of each year the state of Wisconsin investment board shall determine and certify to the department

of veterans affairs the amount of any loss sustained during the 6-month period prior to said July 1 and January 1, respectively, on account of loans purchased pursuant to s. 25.17 (3) (bg). The amount of such loss shall consist of principal amounts of loans so sold which are more than 12 months delinquent in accordance with the monthly instalment dates of the original note securing any particular veterans loan and the amount of income loss arising by reason of veterans loans. The income loss shall be the difference between the amount of interest income received during the 6-month period from all such veterans loans sold to the investment board and the amount that would have been received thereon at the average rate of interest income during the 6-month period from all other investments of the state investment fund; and on any veterans loan investments sold by the investment board pursuant to s. 25.17 (3) (bg), the income loss shall be the difference between the average rate of interest income during the 6-month period from all other investments of the state investment fund and the amount of additional interest and guaranteed principal and interest paid by the investment board to any purchasers of veterans loan investments upon resale. The amount of loss so certified by the state of Wisconsin investment board shall, each period, be paid to the board out of the appropriation under par. (xm).

(xm) *Transfer to state of Wisconsin investment board.* A sum sufficient to pay to the state of Wisconsin investment board for the losses sustained as defined in par. (x).

(y) *Veterans housing loans and expense.* After deducting the appropriations made under pars. (u) to (xm) a sum sufficient for the payment of housing loans granted to veterans, veterans nonprofit housing corporations and veterans nonprofit co-operative housing associations and the payment of expense and other payments as a consequence of being mortgagee or owner under ss. 45.352 and 45.353. All repayments of loans and payments of interest made on loans under ss. 45.352 and 45.353 shall revert to the veterans trust fund.

(z) *Gifts.* All moneys received under s. 45.35 (13) to be used as provided in that section.

SECTION 28. 20.840 (70) to (86) of the statutes are repealed.

SECTION 29. 20.890 (1) (u) and (v) of the statutes are created to read:

20.890 (1) (u) *Administration.* From the moneys received by the Wisconsin retirement fund under ss. 66.90 to 66.9185, the amounts in the schedule for administration, other than investment expenses, audit charges, and transfers to the state deposit fund established by ch. 34. Any balance lapsing from this allotment shall be credited to the appropriation under par. (v).

(v) *Operations and benefits.* All moneys received under ss. 66.90 to 66.9185 after the appropriation for administrative expenses, for operations and benefits, including investment expenses, audit charges, transfers to the state deposit fund established by ch. 34 and the payment of all annuities, death benefits and separation benefits provided in said sections.

SECTION 30. 25.17 (3) (a) of the statutes is amended to read:

25.17 (3) (a) To invest any of the following funds: 1. conservation wardens pension fund; 2. state life fund; 3. state teachers retirement fund system; 4. Milwaukee teachers retirement fund; 5. Wisconsin retirement fund; 6. *veterans trust fund*, in loans, securities and any other investments authorized by s. 206.34, and in bonds or other evidences of indebtedness or preferred stock of companies engaged in the finance business whether as direct lenders or as holding companies owning subsidiaries

engaged in the finance business, provided such investments meet all other requirements of s. 206.34. Such investments previously permitted by s. 206.34 (1) (m) or sub. (4) are deemed to be permitted investments under this subsection.

SECTION 31. 25.24 of the statutes is repealed.

SECTION 32. 25.36 of the statutes is repealed and recreated to read:

25.36 VETERANS TRUST FUND. (1) All moneys appropriated or transferred by law shall constitute the veterans trust fund which shall be used exclusively for veterans and administered by the Wisconsin department of veterans affairs, including all moneys received from the federal government for the benefit of veterans or their dependents; all moneys paid as interest on and repayment of loans under the post-war rehabilitation fund; soldiers rehabilitation fund, veterans housing funds as they existed prior to July 1, 1961; all moneys paid as interest on and repayment of loans under this fund; and all gifts of money received by the board of veterans affairs for the purposes of this fund.

(2) The moneys appropriated from the veterans trust fund by s. 20.840 (2) (y) shall be allocated, on March 1, July 1 and November 1, as follows: \$200,000 to be used by the department for housing loans in those counties which from time to time have exhausted allocations provided herein, and the balance shall be allocated in the several counties as nearly as practicable on the basis of veterans population.

SECTION 33. 25.39 (2) of the statutes is repealed.

SECTION 36. 38.24 (9) (f) of the statutes is created to read:

38.24 (9) (f) Beginning with the 1967 fiscal year the board shall furnish once each year to each member currently making deposits, a statement of his account together with appropriate explanatory material and shall furnish such statement and explanatory material to any other member upon request.

SECTION 39. 42.37 (4) of the statutes is repealed and recreated to read:

42.37 (4) Beginning with the 1967 fiscal year, furnish once each year to each member currently making deposits, a statement of his account together with appropriate explanatory material and shall furnish such statement and explanatory material to any other member upon request.

SECTION 40. 45.38 (7) of the statutes is repealed.

SECTION 43. 66.912 (1) (o) of the statutes is repealed and recreated to read:

66.912 (1) (o) Beginning with the 1967 calendar year, submit once each year to each participant currently making contributions a statement of his account together with appropriate explanatory material and shall furnish such statement and explanatory material to any other participant upon request.

SECTION 45. 66.919 (21) of the statutes is created to read:

66.919 (21) COVERAGE FOR NEW EMPLOYEES. In addition to coverage subsequently provided any person who enters employment in which incumbents are eligible for health insurance under this section and who meets all the requirements of sub. (4) (a) other than the completion of the qualifying period shall be eligible when enrolled pursuant to rule for such health insurance until the end of such qualifying period, but until



the end of the qualifying period the full cost of such coverage shall be paid by such person.

SECTION 46. 210.03 (1) (a) of the statutes is amended to read:

210.03 (1) (a) In case of a loss under policies issued covering state property, the commissioner of insurance shall within a reasonable time ascertain and fix the amount of such damage and forthwith file with the state treasurer and the department of administration a statement of the same. *Losses of \$50 or less in any one occurrence shall not be paid, but shall be charged to the proper appropriation for the department in which such loss occurs.*
