2 **1.** At the appropriate places, insert all of the following:

3 “**SECTION 1.** 121.85 (3) (a) 1. of the statutes is renumbered 121.85 (3) (a) and
4 amended to read:

5 121.85 (3) (a) *Interdistrict*. ~~Subject to subd. 2., the~~ The school board of the
6 district of residence and the school board of the district of attendance may enter into
7 annual written agreements to permit a pupil to attend a public school outside the
8 school district of residence.

5 **SECTION 5.** 121.85 (4) of the statutes is amended to read:

6 121.85 (4) OTHER PLANS TO REDUCE RACIAL IMBALANCE. (a) Pupil transfers
7 resulting from a plan implemented by the school board to reduce racial imbalance
8 in a school district or attendance area shall be deemed to be transfer agreements
9 under sub. (3) and shall be eligible for state aid under this section if the transfers
10 comply with sub. (2), ~~provided the transfers are of pupils who attended a public~~
11 ~~school in a school district or attendance area under the plan in the 2015-16 school~~
12 ~~year.~~

13 (b) Any school board that, prior to May 4, 1976, established a plan to reduce
14 racial imbalance in the school district is eligible for state aid under sub. (6) (a) if the
15 state superintendent approves the plan, ~~provided the transfer pupil attended a~~
16 ~~public school in an attendance area other than the pupil's attendance area under the~~
17 ~~plan in the 2015-16 school year.~~

18 **SECTION 6.** 121.85 (5) (a) of the statutes is renumbered 121.85 (5) and amended
19 to read:

20 121.85 (5) PART-TIME TRANSFERS. ~~Except as provided in par. (b), part-time~~
21 Part-time transfers for curriculum offerings are ~~not also may be~~ permitted under
22 this section. The department shall establish procedures for aid computations in such
23 cases.
