1 At the locations indicated, amend the substitute amendment as follows: 2 **1.** Page 2, line 1: delete lines 1 to 3 and substitute: **"Section 1m.** 15.374 (2) of the statutes is created to read: 3 15.374 (2) Office of school safety. There is created an office of school safety 4 in the department of public instruction. The director of the office shall be appointed 5 6 by the state superintendent of public instruction.". **2.** Page 2, line 4: delete lines 4 to 16 and substitute: 7 "Section 4m. 20.255 (2) (im) of the statutes is created to read: 8 9 20.255 (2) (im) Training to school staff. All moneys received from fees collected

under s. 115.335 (3) to provide training to school staff under s. 115.335 (3).

8	school safety. The department of justice shall provide any resources or staff
9	requested by the office to create the model practices. The office shall also consult the
10	Wisconsin School Safety Coordinators Association and the Wisconsin Safe and
11	Healthy Schools Training and Technical Assistance Center.
12	(2) Coordinate with schools under s. 118.07 (4) (cf) and the department of
13	administration to compile blueprints and geographic information system maps for
14	all schools. The office shall keep all blueprints and maps confidential unless a law
15	enforcement agency requests access to the blueprints or maps.
16	(3) Offer, or contract with another party to offer, training to school staff on
L7	school safety. Training subjects may include trauma informed care and how adverse
18	childhood experiences have an impact on a child's development and increase needs
19	for counseling or support. If a school receives under s. 115.337 (2) (b) a grant for the

training under this subsection, the office may charge a fee for the training.".

In the schedule under section 20.005 (3) of the statutes for the appropriation to the department of public instruction under section 20.255 (1) (a) of the statutes, the dollar amount for fiscal year 2017–18 is increased by \$91,100 to fund the 4.0 FTE GPR positions authorized under Section 29 (1m) of this act. In the schedule under section 20.005 (3) of the statutes for the appropriation to the department of public instruction under section 20.255 (1) (a) of the statutes, the dollar amount for fiscal year 2018–19 is increased by \$364,500 to fund the 4.0 FTE GPR positions authorized under Section 29 (1m) of this act.".
