**ASSEMBLY AMENDMENT 1,
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO ASSEMBLY BILL 396**

January 10, 2022 - Offered by Representative CABRAL-GUEVARA.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 44, line 19: after that line insert:

3 "5m. If the applicant wishes to practice advanced practice registered nursing
4 outside the context of an employment relationship with an employer, the applicant
5 provides to the board evidence required under sub. (3) (cm) 2. a., b., c., or d."

6 **2.** Page 45, line 3: delete the material beginning with "The board" and ending
7 with "par. (a)" on line 6 and substitute "Based on the applicant's qualifications under
8 par. (a), the board shall also grant an applicant who is granted a license under this
9 subd. 1. a. one or more specialty designations corresponding to the recognized roles
10 for which the board determines that the applicant qualifies, along with any
11 authorizations to practice under sub. (3) (cm) 3. for which the board determines that
12 the applicant qualifies."

1 **3.** Page 45, line 8: on lines 8 and 14, delete “individual” and substitute
2 “person”.

3 **4.** Page 45, line 12: after “qualifications.” insert “If the person wishes to
4 practice advanced practice registered nursing outside the context of an employment
5 relationship with an employer, the person may apply to the board for authorization
6 to do so under sub. (3) (cm) 2.”.

7 **5.** Page 45, line 17: after “designation.” insert “If the person wishes to practice
8 nurse-midwifery outside the context of an employment relationship with an
9 employer, the person may apply to the board for authorization to do so under sub. (3)
10 (cm) 2.”.

11 **6.** Page 45, line 19: after “license” insert “along with any notations under sub.
12 (3) (cm) 3.”.

13 **7.** Page 48, line 14: after that line insert:

14 “(cm) 1. Except as provided in subd. 3., an advanced practice registered nurse
15 may practice advanced practice registered nursing only within the context of an
16 employment relationship with an employer.

17 2. An advanced practice registered nurse or an applicant for a license under
18 this section may apply to the board for authorization to practice advanced practice
19 registered nursing outside the context of an employment relationship with employer
20 in one of the 4 recognized roles by providing to the board evidence that the advanced
21 practice registered nurse or applicant satisfies one of the following:

22 a. The person has at least one year of experience practicing in that recognized
23 role after the person became licensed under this section as an advanced practice
24 registered nurse.
