TO ASSEMBLY SUBSTITUTE AMENDMENT 2,  
TO ASSEMBLY BILL 68**

June 29, 2021 – Offered by Representatives SUBECK, ANDERSON, ANDRACA, BALDEH, BILLINGS, BOWEN, BROSTOFF, CABRERA, CONLEY, CONSIDINE, DOYLE, DRAKE, EMERSON, GOYKE, HAYWOOD, HEBL, HESSELBEIN, HINTZ, HONG, MCGUIRE, B. MEYERS, MILROY, MOORE OMOKUNDE, L. MYERS, NEUBAUER, OHNSTAD, ORTIZ-VELEZ, POPE, RIEMER, S. RODRIGUEZ, SHANKLAND, SHELTON, SINICKI, SNODGRASS, SPREITZER, STUBBS, VINING and VRUWINK.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 8, line 9: after that line insert:

3 “**SECTION 9g.** 15.07 (3) (bm) 7. of the statutes is created to read:

4 15.07 (3) (bm) 7. The prescription drug affordability review board shall meet  
5 at least 4 times each year.

6 **SECTION 9m.** 15.197 (20) of the statutes is created to read:

7 15.197 (20) SPINAL CORD INJURY COUNCIL. (a) There is created in the department  
8 of health services a spinal cord injury council that, except as provided in par. (b),  
9 consists of the following members appointed by the department for 2-year terms:

10 1. One member representing the University of Wisconsin School of Medicine  
11 and Public Health.

12 2. One member representing the Medical College of Wisconsin.

- 1           3. One member who has a spinal cord injury.
- 2           4. One member who is a family member of a person with a spinal cord injury.
- 3           5. One member who is a veteran who has a spinal cord injury.
- 4           6. One member who is a physician specializing in the treatment of spinal cord
- 5 injuries.
- 6           7. One member who is a researcher in the field of neurosurgery.
- 7           8. One member who is a researcher employed by the veterans health
- 8 administration of the U.S. department of veterans affairs.

9           (b) If the department of health services is unable to appoint a member specified  
10 in par. (a) 1. to 8., the department of health services may appoint a member  
11 representing the general public in lieu of the member so specified.”.

12           **2.** Page 8, line 14: after that line insert:

13           “**SECTION 10m.** 15.735 of the statutes is created to read:

14           **15.735 Same; attached board.** (1) There is created a prescription drug  
15 affordability review board attached to the office of the commissioner of insurance  
16 under s. 15.03. The board shall consist of the following members:

17           (a) The commissioner of insurance or his or her designee.

18           (b) Two members appointed for 4-year terms who represent the  
19 pharmaceutical drug industry, including pharmaceutical drug manufacturers and  
20 wholesalers. At least one of the members appointed under this paragraph shall be  
21 a licensed pharmacist.

22           (c) Two members appointed for 4-year terms who represent the health  
23 insurance industry, including insurers and pharmacy benefit managers.

1 (d) Two members appointed for 4-year terms who represent the health care  
2 industry, including hospitals, physicians, pharmacies, and pharmacists. At least one  
3 of the members appointed under this paragraph shall be a licensed practitioner.

4 (e) Two members appointed for 4-year terms who represent the interests of the  
5 public.

6 (2) A member appointed under sub. (1) may not be an employee of, a board  
7 member of, or a consultant to a drug manufacturer or trade association for drug  
8 manufacturers.

9 (3) Any conflict of interest, including any financial or personal association, that  
10 has the potential to bias or has the appearance of biasing an individual's decision in  
11 matters related to the board or the conduct of the board's activities shall be  
12 considered and disclosed when appointing that individual to the board under sub.  
13 (1).”.

16 **4.** Page 36, line 19: increase the dollar amount for fiscal year 2022-23 by  
17 \$3,000,000 for the purpose of developing and implementing a state-based health  
18 insurance exchange as described in this act.

19 **5.** Page 36, line 19: increase the dollar amount for fiscal year 2022-23 by  
20 \$900,000 for an analysis and actuarial study for the development of a public option  
21 health insurance plan.

22 **6.** Page 36, line 19: increase the dollar amount for fiscal year 2021-22 by  
23 \$1,701,000 to provide \$500,000 in onetime implementation costs for establishing an  
24 office of prescription drug affordability in the office of the commissioner of insurance

1 and \$1,201,000 to authorize 16.0 PR positions within the office of prescription drug  
2 affordability, including 5.0 insurance examiners, 4.0 policy initiatives advisors, 2.0  
3 attorneys, 1.0 insurance program manager, 2.0 insurance administrators, and 2.0  
4 operations program associates and increase the dollar amount for fiscal year  
5 2022-23 by \$1,533,900 for the purpose of funding these authorized positions.

6 **7.** Page 134, line 4: increase the dollar amount for fiscal year 2021-22 by  
7 \$1,564,300 and increase the dollar amount for fiscal year 2022-23 by \$2,044,100 for  
8 the purpose of increasing the authorized FTE positions for the department of health  
9 services by 23.0 GPR positions, including 17.0 permanent positions and 6.0 4-year  
10 project positions, beginning in fiscal year 2021-22, for the bureau of communicable  
11 diseases to prevent and respond to future outbreaks of communicable disease.

12 **8.** Page 134, line 4: increase the dollar amount for fiscal year 2021-22 by  
13 \$189,300 and increase the dollar amount for fiscal year 2022-23 by \$246,000 for the  
14 purpose of increasing the authorized FTE positions for the department of health  
15 services by 3.0 GPR positions, beginning in fiscal year 2021-22, to create a field team  
16 in the bureau of communicable diseases dedicated to harm reduction.

17 **9.** Page 134, line 4: increase the dollar amount for fiscal year 2021-22 by  
18 \$162,400 and increase the dollar amount for fiscal year 2022-23 by \$213,500 for the  
19 purpose of increasing the authorized FTE positions for the department of health  
20 services by 2.0 GPR positions, beginning in fiscal year 2021-22, to create a data  
21 analysis team in the office of health informatics consisting of a senior statistician and  
22 a modeler, dedicated to analyzing health metrics and creating predictive models to  
23 inform public health responses.

1           **10.** Page 134, line 4: increase the dollar amount for fiscal year 2021-22 by  
2           \$116,600 and increase the dollar amount for fiscal year 2022-23 by \$153,100 for the  
3           purpose of converting 2.0 FED positions in the department of health services to 2.0  
4           GPR positions, beginning in fiscal year 2021-22, to support 1.0 state trauma  
5           coordinator and 1.0 trauma program associate with state funds rather than funds  
6           received under the federal hospital preparedness program.

7           **11.** Page 134, line 4: increase the dollar amount for fiscal year 2021-22 by  
8           \$100,000 and increase the dollar amount for fiscal year 2022-23 by \$100,000 for the  
9           purpose of contracting for the services of one full-time web developer in the division  
10          of public health to translate the Internet pages of the department of health services  
11          into multiple languages.

12          **12.** Page 134, line 4: increase the dollar amount for fiscal year 2021-22 by  
13          \$66,200 and increase the dollar amount for fiscal year 2022-23 by \$88,200 for the  
14          purpose of increasing the authorized FTE positions for the department of health  
15          services by 1.0 GPR position, beginning in fiscal year 2021-22, to create an  
16          interdepartmental team to promote health in all policies.

17          **13.** Page 134, line 4: increase the dollar amount for fiscal year 2022-23 by  
18          \$87,600 for the purpose of increasing the authorized FTE positions for the  
19          department of health services by 1.0 GPR position, beginning in fiscal year 2022-23,  
20          to oversee a self-reported compliance program for ambulance medical equipment  
21          and operational requirements and conduct inspections as necessary.

22          **14.** Page 134, line 8: increase the dollar amount for fiscal year 2021-22 by  
23          \$655,000 and increase the dollar amount for fiscal year 2022-23 by \$655,000 for  
24          grants to support health information exchange activities.

1           **15.** Page 134, line 8: increase the dollar amount for fiscal year 2021-22 by  
2           \$500,000 and increase the dollar amount for fiscal year 2022-23 by \$500,000 for the  
3           purpose of awarding a grant in each fiscal year to an entity to connect and convene  
4           efforts among state agencies, public and private sector organizations, and  
5           community organizations to support a statewide public health strategy to advance  
6           Black women’s health.

12          communicable diseases.

14          \$125,000 and increase the dollar amount for fiscal year 2022-23 by \$125,000 for the  
15          purpose of awarding a grant to an organization to train and assist guardians for  
16          individuals found to be incompetent under ch. 54.

3           the purpose of increasing the authorized FTE positions for the department of health

5           Plus lead exposure prevention program.

12 at least 15 percent lower than the referenced brand biologic at the time the biosimilar

15 to reflect adjustments to the U.S. consumer price index for all urban consumers, U.S.  
16 city average, as determined by the U.S. department of labor, that meets all of the  
17 following conditions:

18 1. Is at least \$100 for a supply lasting a patient for a period of 30 consecutive  
19 days based on the recommended dosage approved for labeling by the U.S. food and  
20 drug administration, a supply lasting a patient for fewer than 30 days based on the  
21 recommended dosage approved for labeling by the federal food and drug  
22 administration, or one unit of the drug if the labeling approved by the federal food  
23 and drug administration does not recommend a finite dosage.

1           2. Increased by at least 200 percent during the preceding 12-month period, as  
2 determined by the difference between the resulting wholesale acquisition cost and  
3 the average of the wholesale acquisition cost reported over the preceding 12 months.

4           (d) Other prescription drug products, including drugs to address public health  
5 emergencies, that may create affordability challenges for the health care system and

7           **(2) AFFORDABILITY REVIEW.** (a) After identifying prescription drug products

13 (d) The price at which therapeutic alternatives have been sold in this state.

14 (e) The average monetary concession, discount, or rebate the manufacturer  
15 provides or is expected to provide to health plan payors and pharmacy benefit  
16 managers in this state for therapeutic alternatives.

17 (f) The costs to health plans based on patient access consistent with labeled  
18 indications by the federal food and drug administration and recognized standard  
19 medical practice.

20 (g) The impact on patient access resulting from the cost of the prescription drug  
21 product relative to insurance benefit design.

22 (h) The current or expected dollar value of drug-specific patient access  
23 programs that are supported by the manufacturer.

1 (i) The relative financial impacts to health, medical, or social services costs that  
2 can be quantified and compared to baseline effects of existing therapeutic  
3 alternatives.

4 (j) The average patient copay or other cost sharing for the prescription drug  
5 product in the state.

6 (k) Any information a manufacturer chooses to provide.

7 (L) Any other factors as determined by the board by rule.

8 **(4) UPPER PAYMENT LIMIT.** (a) If the board determines under sub. (3) that use  
9 of a prescription drug product has led or will lead to an affordability challenge, the  
10 board shall establish an upper payment limit for the prescription drug product after  
11 considering all of the following:

12 1. The cost of administering the drug.

13 2. The cost of delivering the drug to consumers.

14 3. Other relevant administrative costs related to the drug.

15 (b) For a prescription drug product identified in sub. (1) (d), the board shall  
16 solicit information from the manufacturer regarding the price increase. To the  
17 extent that the price increase is not a result of the need for increased manufacturing

19 collect a copayment, not to exceed \$35, from the individual to cover the pharmacy's  
20 costs of processing and dispensing the insulin. The pharmacy shall notify the health  
21 care practitioner who issued the prescription no later than 72 hours after the insulin  
22 is dispensed.

23           3. A pharmacy that dispenses insulin under subd. 2. may submit to the  
24 manufacturer, or the manufacturer's vendor, a claim for payment that is in  
25 accordance with the national council for prescription drug programs' standards for

1 electronic claims processing, except that no claim may be submitted if the  
2 manufacturer agrees to send the pharmacy a replacement of the same insulin in the  
3 amount dispensed. If the pharmacy submits an electronic claim, the manufacturer  
4 or vendor shall reimburse the pharmacy in an amount that covers the pharmacy's  
5 acquisition cost.

6 4. A pharmacy that dispenses insulin under subd. 2. shall retain a copy of the  
7 application form described in subd. 1. a.

8 (d) *Eligibility of certain individuals.* An individual who has applied for public  
9 assistance under ch. 49 but for whom a determination of eligibility has not been made  
10 or whose coverage has not become effective or an individual who has an appeal  
11 pending under sub. (3) c. 4. may access insulin under this subsection if the individual  
12 is in urgent need of insulin. To access a 30-day supply of insulin, the individual shall  
13 attest to the pharmacy that the individual is described in this paragraph and comply  
14 with par. (c) 1.

15 (3) PATIENT ASSISTANCE PROGRAM. (a) *Establishment of program.* No later than  
16 July 1, 2022, each manufacturer shall establish a patient assistance program to  
17 make insulin available in accordance with this subsection to individuals who meet  
18 the eligibility requirements under par. (b). Under the program, the manufacturer  
19 shall do all of the following:

20 1. Provide the commissioner with information regarding the program,  
21 including contact information for individuals to call for assistance in accessing the  
22 program.

23 2. Provide a hotline for individuals to call or access between 8 a.m. and 10 p.m.  
24 on weekdays and between 10 a.m. and 6 p.m. on Saturdays.

1           3. List the eligibility requirements under par. (b) on the manufacturer's  
2 Internet site.

3           4. Maintain the privacy of all information received from an individual applying  
4 for or participating in the program and not sell, share, or disseminate the  
5 information unless required under this section or authorized, in writing, by the  
6 individual.

7           (b) *Eligible individual*. An individual shall be eligible to receive insulin under  
8 a patient assistance program if all of the following conditions are met:

9           1. The individual is a resident of this state.

10          2. The individual, or the individual's parent or legal guardian if the individual  
11 is under the age of 18, has a valid Wisconsin driver's license or state identification  
12 card.

13          3. The individual has a valid insulin prescription.

14          4. The family income of the individual does not exceed 400 percent of the  
15 poverty line as defined and revised annually under 42 USC 9902 (2) for a family the  
16 size of the individual's family,

17          5. The individual is not receiving public assistance under ch. 49.

18          6. The individual is not eligible to receive health care through a federally  
19 funded program or receive prescription drug benefits through the U.S. department  
20 of veterans affairs, except that this subdivision does not apply to an individual who  
21 is enrolled in a policy under Part D of Medicare under 42 USC 1395w-101 et seq. if  
22 the individual has spent at least \$1,000 on prescription drugs in the current calendar  
23 year.

24          7. The individual is not enrolled in prescription drug coverage through an  
25 individual or group health plan that limits the total cost sharing amount, including



1 copayments, deductibles, and coinsurance, that an enrollee is required to pay for a  
2 30-day supply of insulin to no more than \$75, regardless of the type or amount of  
3 insulin needed.

4 (c) *Application for patient assistance program.* 1. An individual may apply to  
5 participate in a patient assistance program by filing an application with the  
6 manufacturer who established the program, the individual's health care practitioner  
7 if the practitioner participates in the program, or a navigator included on the list  
8 under sub. (8) (c). A health care practitioner or navigator shall immediately submit  
9 the application to the manufacturer. Upon receipt of an application, the  
10 manufacturer shall determine the individual's eligibility under par. (b) and, except  
11 as provided in subd. 2., notify the individual of the determination no later than 10  
12 days after receipt of the application.

13 2. If necessary to determine the individual's eligibility under par. (b), the  
14 manufacturer may request additional information from an individual who has filed  
15 an application under subd. 1. no later than 5 days after receipt of the application.  
16 Upon receipt of the additional information, the manufacturer shall determine the  
17 individual's eligibility under par. (b) and notify the individual of the determination  
18 no later than 3 days after receipt of the requested information.

19 3. Except as provided in subd. 5., if the manufacturer determines under subd.  
20 1. or 2. that the individual is eligible for the patient assistance program, the  
21 manufacturer shall provide the individual with a statement of eligibility. The  
22 statement of eligibility shall be valid for 12 months and may be renewed upon a  
23 determination by the manufacturer that the individual continues to meet the  
24 eligibility requirements of par. (b).

1           4. If the manufacturer determines under subd. 1. or 2. that the individual is not  
2 eligible for the patient assistance program, the manufacturer shall provide the  
3 reason for the determination in the notification under subd. 1. or 2. The individual  
4 may appeal the determination by filing an appeal with the commissioner that shall  
5 include all of the information provided to the manufacturer under subds. 1. and 2.  
6 The commissioner shall establish procedures for deciding appeals under this  
7 subdivision. The commissioner shall issue a decision no later than 10 days after the  
8 appeal is filed, and the commissioner's decision shall be final. If the commissioner  
9 determines that the individual meets the eligibility requirements under par. (b), the  
10 manufacturer shall provide the individual with the statement of eligibility described  
11 in subd. 3.

12           5. In the case of an individual who has prescription drug coverage through an  
13 individual or group health plan, if the manufacturer determines under subd. 1. or 2.  
14 that the individual is eligible for the patient assistance program but also determines  
15 that the individual's insulin needs are better addressed through the use of the  
16 manufacturer's copayment assistance program rather than the patient assistance  
17 program, the manufacturer shall inform the individual of the determination and  
18 provide the individual with the necessary coupons to submit to a pharmacy. The  
19 individual may not be required to pay more than the copayment amount specified in  
20 par. (d) 2.

21           (d) *Provision of insulin under a patient assistance program.* 1. Upon receipt  
22 from an individual of the eligibility statement described in par. (c) 3. and a valid  
23 insulin prescription, a pharmacy shall submit an order containing the name of the  
24 insulin and daily dosage amount to the manufacturer. The pharmacy shall include  
25 with the order the pharmacy's name, shipping address, office telephone number, fax

1 number, electronic mail address, and contact name, as well as any days or times  
2 when deliveries are not accepted by the pharmacy.

3 2. Upon receipt of an order meeting the requirements under subd. 1., the  
4 manufacturer shall send the pharmacy a 90-day supply of insulin, or lesser amount  
5 if requested in the order, at no charge to the individual or pharmacy. The pharmacy  
6 shall dispense the insulin to the individual associated with the order. The insulin  
7 shall be dispensed at no charge to the individual, except that the pharmacy may  
8 collect a copayment from the individual to cover the pharmacy's costs for processing  
9 and dispensing in an amount not to exceed \$50 for each 90-day supply of insulin.  
10 The pharmacy may not seek reimbursement from the manufacturer or a 3rd-party  
11 payer.

12 3. The pharmacy may submit a reorder to the manufacturer if the individual's  
13 eligibility statement described in par. (c) 3. has not expired. The reorder shall be  
14 treated as an order for purposes of subd. 2.

15 4. Notwithstanding subds. 2. and 3., a manufacturer may send the insulin  
16 directly to the individual if the manufacturer provides a mail-order service option,  
17 in which case the pharmacy may not collect a copayment from the individual.

18 **(4) EXCEPTIONS.** (a) This section does not apply to a manufacturer who shows  
19 to the commissioner's satisfaction that the manufacturer's annual gross revenue  
20 from insulin sales in this state does not exceed \$2,000,000.

21 (b) A manufacturer may not be required to make an insulin product available  
22 under sub. (2) or (3) if the wholesale acquisition cost of the insulin product does not  
23 exceed \$8, as adjusted annually based on the U.S. consumer price index for all urban  
24 consumers, U.S. city average, per milliliter or the applicable national council for  
25 prescription drug programs' plan billing unit.

1           **(5) CONFIDENTIALITY.** All medical information solicited or obtained by any  
2 person under this section shall be subject to the applicable provisions of state law  
3 relating to confidentiality of medical information, including s. 610.70.

4           **(6) REIMBURSEMENT PROHIBITION.** No person, including a manufacturer,  
5 pharmacy, pharmacist, or 3rd-party administrator, as part of participating in an  
6 urgent need safety net program or patient assistance program may request or seek,  
7 or cause another person to request or seek, any reimbursement or other  
8 compensation for which payment may be made in whole or in part under a federal  
9 health care program, as defined in 42 USC 1320a-7b (f).

10           **(7) REPORTS.** (a) Annually, no later than March 1, each manufacturer shall  
11 report to the commissioner all of the following information for the previous calendar  
12 year:

13           1. The number of individuals who received insulin under the manufacturer's  
14 urgent need safety net program.

15           2. The number of individuals who sought assistance under the manufacturer's  
16 patient assistance program and the number of individuals who were determined to  
17 be ineligible under sub. (3) (c) 4.

18           3. The wholesale acquisition cost of the insulin provided by the manufacturer  
19 through the urgent need safety net program and patient assistance program.

20           (b) Annually, no later than April 1, the commissioner shall submit to the  
21 governor and the chief clerk of each house of the legislature, for distribution to the  
22 legislature under s. 13.172 (2), a report on the urgent need safety net programs and  
23 patient assistance programs that includes all of the following:

24           1. The information provided to the commissioner under par. (a).

1           2. The penalties assessed under sub. (9) during the previous calendar year,  
2 including the name of the manufacturer and amount of the penalty.

3           **(8) ADDITIONAL RESPONSIBILITIES OF COMMISSIONER.** (a) *Application form.* The  
4 commissioner shall make the application form described in sub. (2) (c) 1. a. available  
5 on the office's Internet site and shall make the form available to pharmacies and  
6 health care providers who prescribe or dispense insulin, hospital emergency  
7 departments, urgent care clinics, and community health clinics.

8           (b) *Public outreach.* 1. The commissioner shall conduct public outreach to  
9 create awareness of the urgent need safety net programs and patient assistance  
10 programs.

11           2. The commissioner shall develop and make available on the office's Internet  
12 site an information sheet that contains all of the following information:

13           a. A description of how to access insulin through an urgent need safety net  
14 program.

15           b. A description of how to access insulin through a patient assistance program.

16           c. Information on how to contact a navigator for assistance in accessing insulin  
17 through an urgent need safety net program or patient assistance program.

18           d. Information on how to contact the commissioner if a manufacturer  
19 determines that an individual is not eligible for a patient assistance program.

20           e. A notification that an individual may contact the commissioner for more  
21 information or assistance in accessing ongoing affordable insulin options.

22           (c) *Navigators.* The commissioner shall develop a training program to provide  
23 navigators with information and the resources necessary to assist individuals in  
24 accessing appropriate long-term insulin options. The commissioner shall compile  
25 a list of navigators who have completed the training program and are available to

1 assist individuals in accessing affordable insulin coverage options. The list shall be  
2 made available on the office's Internet site and to pharmacies and health care  
3 practitioners who dispense and prescribe insulin.

4 (d) *Satisfaction surveys.* 1. The commissioner shall develop and conduct a  
5 satisfaction survey of individuals who have accessed insulin through urgent need  
6 safety net programs and patient assistance programs. The survey shall ask whether  
7 the individual is still in need of a long-term solution for affordable insulin and shall  
8 include questions about the individual's satisfaction with all of the following, if  
9 applicable:

10 a. Accessibility to urgent-need insulin.

11 b. Adequacy of the information sheet and list of navigators received from the  
12 pharmacy.

13 c. Helpfulness of a navigator.

14 d. Ease of access in applying for a patient assistance program and receiving  
15 insulin from the pharmacy under the program.

16 2. The commissioner shall develop and conduct a satisfaction survey of  
17 pharmacies that have dispensed insulin through urgent need safety net programs  
18 and patient assistance programs. The survey shall include questions about the  
19 pharmacy's satisfaction with all of the following, if applicable:

20 a. Timeliness of reimbursement from manufacturers for insulin dispensed by  
21 the pharmacy under urgent need safety net programs.

22 b. Ease in submitting insulin orders to manufacturers.

23 c. Timeliness of receiving insulin orders from manufacturers.

24 3. The commissioner may contract with a nonprofit entity to develop and  
25 conduct the surveys under subds. 1. and 2. and to evaluate the survey results.

1           4. No later than July 1, 2024, the commissioner shall submit to the governor  
2 and the chief clerk of each house of the legislature, for distribution to the legislature  
3 under s. 13.172 (2), a report on the results of the surveys under subds. 1. and 2.

4           **(9) PENALTY.** A manufacturer that fails to comply with this section may be  
5 assessed a penalty of up to \$200,000 per month of noncompliance, with the maximum  
6 penalty increasing to \$400,000 per month if the manufacturer continues to be in  
7 noncompliance after 6 months and increasing to \$600,000 per month if the  
8 manufacturer continues to be in noncompliance after one year.

9           **SECTION 412ze.** 632.869 of the statutes is created to read:

10           **632.869 Reimbursement to federal drug pricing program participants.**

11           **(1)** In this section:

12           (a) “Covered entity” means an entity described in 42 USC 256b (a) (4) (A), (D),

14 256b, a pharmacy of the entity, or a pharmacy contracted with the entity to dispense  
15 drugs purchased through the federal drug pricing program under 42 USC 256b.

17           **(2)** Any person, including a pharmacy benefit manager and 3rd-party payer,  
18 may not do any of the following:

19           (a) Reimburse a covered entity for a drug that is subject to an agreement under  
20 42 USC 256b at a rate lower than that paid for the same drug to pharmacies that are  
21 not covered entities and are similar in prescription volume to the covered entity.

22           (b) Assess a covered entity any fee, charge back, or other adjustment on the  
23 basis of the covered entity’s participation in the federal drug pricing program under  
24 42 USC 256b.

25           **SECTION 412zg.** 632.871 of the statutes is created to read:

1           **632.871 Telehealth services. (1) DEFINITIONS.** In this section:

2           (a) “Disability insurance policy” has the meaning given in s. 632.895 (1) (a).

3           (b) “Self-insured health plan” has the meaning given in s. 632.85 (1) (c).

4           (c) “Telehealth” means a practice of health care delivery, diagnosis,  
5           consultation, treatment, or transfer of medically relevant data by means of audio,  
6           video, or data communications that are used either during a patient visit or a  
7           consultation or are used to transfer medically relevant data about a patient.  
8           “Telehealth” does not include communications delivered solely by audio-only  
9           telephone, facsimile machine, or e-mail unless specified otherwise by rule.

10           **(2) COVERAGE DENIAL PROHIBITED.** No disability insurance policy or self-insured

12           telehealth on the basis that the treatment or service is provided through telehealth

14           A disability insurance policy or self-insured health plan may limit coverage of  
15           treatments or services provided through telehealth to those treatments or services  
16           that are medically necessary.

17           **(3) CERTAIN LIMITATIONS ON TELEHEALTH PROHIBITED.** A disability insurance  
18           policy or self-insured health plan may not subject a treatment or service provided  
19           through telehealth for which coverage is required under sub. (2) to any of the  
20           following:

21           (a) Any greater deductible, copayment, or coinsurance amount than would be  
22           applicable if the treatment or service is provided in person.

23           (b) Any policy or calendar year or lifetime benefit limit or other maximum  
24           limitation that is not imposed on other treatments or services covered by the plan  
25           that are not provided through telehealth.



1 (c) Prior authorization requirements that are not required for the same  
2 treatment or service when provided in person.

3 (d) Unique location requirements.

4 **(4) DISCLOSURE OF COVERAGE OF CERTAIN TELEHEALTH SERVICES.** A disability  
5 insurance policy or self-insured health plan that covers a telehealth treatment or  
6 service that has no equivalent in-person treatment or service, such as remote patient  
7 monitoring, shall specify in policy or plan materials the coverage of that telehealth  
8 treatment or service.

17 medication, used in the treatment of diabetes, and coverage of diabetic

- 6           4. Human papillomavirus testing for women who have attained the age of 30  
7 years but have not attained the age of 66 years.
- 8           5. Colorectal cancer screening in accordance with sub. (16m).
- 9           6. Annual tomography for lung cancer screening for adults who have attained  
10 the age of 55 years but have not attained the age of 80 years and who have health  
11 histories demonstrating a risk for lung cancer.
- 12           7. Skin cancer screening for individuals who have attained the age of 10 years  
13 but have not attained the age of 22 years.
- 14           8. Counseling for skin cancer prevention for adults who have attained the age

17 65 years but have not attained the age of 75 years and who have ever smoked.

- 5           28. Body mass index for minors 2 years of age or older.
- 6           29. Blood pressure measurements for minors 3 years of age or older and a blood  
7           pressure risk assessment at birth.
- 8           30. Risk assessment and referral for oral health issues for minors who have  
9           attained the age of 6 months but have not attained the age of 7 years.
- 10          31. Blood screening for newborns and minors who have not attained the age of  
11          2 months.
- 12          32. Screening for critical congenital health defects for newborns.
- 13          33. Lead screenings in accordance with sub. (10).
- 14          34. Metabolic and hemoglobin screening and screening for phenylketonuria,  
15          sickle cell anemia, and congenital hypothyroidism for minors including newborns.
- 16          35. Tuberculin skin test based on risk assessment for minors one month of age  
17          or older.
- 18          36. Tobacco counseling and cessation interventions for individuals who are 5  
19          years of age or older.
- 20          37. Vision and hearing screening and assessment for minors including  
21          newborns.
- 22          38. Sexually transmitted infection and human immunodeficiency virus  
23          counseling for sexually active minors.

1           39. Risk assessment for sexually transmitted infection for minors who are 10  
2 years of age or older and screening for sexually transmitted infection for minors who  
3 are 16 years of age or older.

4           40. Alcohol misuse screening and counseling for minors 11 years of age or older.

5           41. Autism screening for minors who have attained the age of 18 months but  
6 have not attained the age of 25 months.

7           42. Developmental screening and surveillance for minors including newborns.

8           43. Psychosocial and behavioral assessment for minors including newborns.

9           44. Alcohol misuse screening and counseling for pregnant adults and a risk  
10 assessment for all adults.

11          45. Fall prevention and counseling and preventive medication for fall  
12 prevention for community-dwelling adults 65 years of age or older.

13          46. Screening and counseling for intimate partner violence for adult women.

14          47. Well-woman visits for women who have attained the age of 18 years but  
15 have not attained the age of 65 years and well-woman visits for recommended  
16 preventive services, preconception care, and prenatal care.

17          48. Counseling on, consultations with a trained provider on, and equipment  
18 rental for breastfeeding for pregnant and lactating women.

19          49. Folic acid supplement for adult women with reproductive capacity.

20          50. Iron deficiency anemia screening for pregnant and lactating women.
