### EXECUTIVE ORDER NO. 63

(Pertaining to the Calling of a Special Election  
in the 4th Senate District of Wisconsin)

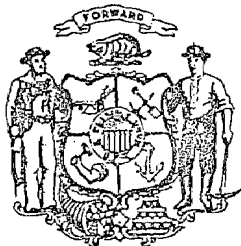
WHEREAS, by a letter dated December 21, 1978, Acting Governor Martin J. Schreiber is informed by State Senator F. James Sensenbrenner, Jr. of the 4th Senate District of Wisconsin that he, Senator Sensenbrenner, is resigning from the Office of State Senator effective January 3, 1979, and

WHEREAS, under the aforementioned circumstances and for purposes of ordering special elections a vacancy exists under law pursuant to Chapter 450, Laws of 1977 in the 4th Senate District of Wisconsin for the term of office expiring the first Monday in January of 1981.

NOW, THEREFORE, I MARTIN J. SCHREIBER, Acting Governor of the State of Wisconsin, by virtue of the authority vested in me by the Wisconsin Constitution and state law, and with particularity by Chapter 450, Laws of 1977, do hereby order that:

1. A Special Election be held on April 3, 1979, to coincide with the regular Spring Election, to fill the vacancy in the 4th Senate District of Wisconsin for the term of office expiring on the first Monday in January of 1981, said Senate District encompassing those parts of the counties of Milwaukee, Ozaukee and Washington as particularly described in Section 4.04 Wisconsin Statutes; and further order that:
2. The Special Primary, if required, shall be held on February 20, 1979, to coincide with the regular Spring Primary; and further that:
3. The circulation of nominating papers for partisan and independent candidates may commence December 22, 1978; and the deadline for filing nomination papers for partisan and independent candidates shall be 5:00 p.m., January 11, 1979; and further and finally order that:

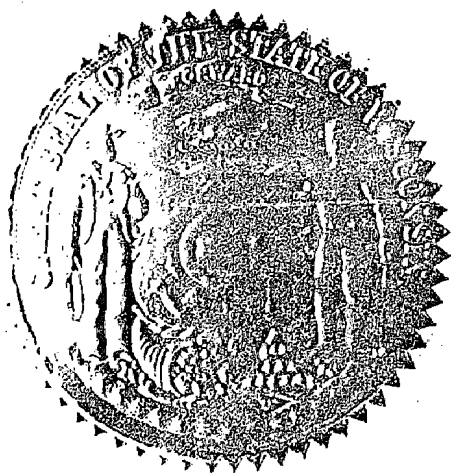
