EXECUTIVE ORDER #213

Relating to Proclamation of an Energy Emergency

WHEREAS, the health, welfare, and economic well-being of the citizens of Wisconsin depend on heating fuel; and,

WHEREAS, there has been unusually cold weather in Wisconsin and there is an imperative need for heating fuel; and,

WHEREAS, allowing for the transportation of increased loads of heating fuel within this state, in a safe manner and as described in this order, will help enable the citizens of Wisconsin to heat their homes;


NOW, THEREFORE, I, TOMMY G. THOMPSON, Governor of the State of Wisconsin, by the authority vested in me by the Constitution and the laws of this State, and specifically by Wisconsin Statute section 166.03(1)(b)1, 340.01(15s), and 348.27(8), do hereby declare the present condition of cold weather, along with the shortage of heating fuel, to be a natural disaster and hereby proclaim the entire State of Wisconsin to be in a state of emergency for a period of 10 days.

PURSUANT to said state of emergency, by virtue of the authority vested in me by the Constitution and Laws of Wisconsin, and ss. 166.03(1)(b)1, 340.01(15s), and 348.27(8) Wisconsin Statutes, I HEREBY ORDER THAT:

- (1) Notwithstanding ss. 348.15, 348.16, and 348.25(4), Wisconsin Statutes, during the period of the state of emergency, persons are allowed to transport loads of heating fuel even when such loads exceed the statutory weight limitations by 15% of the gross vehicle weight, and 10% of the gross axle and axle combination weight limits, except on the national system of interstate and defense highways in Wisconsin.

(2) This order does not suspend the operation of any state or federal laws within the State of Wisconsin except as specifically described in the order. All other laws remain in full force and will be enforced. This order does not authorize any person transporting fuel to exceed any statutory vehicle width, length, or height limit. This order does not authorize the use of unregistered or improperly registered vehicles. Vehicles registered in other jurisdictions and not entitled to reciprocity, or not registered for use in Wisconsin through the International Registration Plan, must obtain a permit as provided in s. 341.41, Wisconsin Statutes. Motor carriers hauling heating fuel for hire must have proper authority to operate in this State, as provided by s. 194.04, Wisconsin Statutes, and must meet the insurance requirements of ss. 194.41 or 194.42, Wisconsin Statutes. Carriers must satisfy all ordinarily applicable federal and Wisconsin requirements concerning vehicle equipment, vehicle operations and driver qualifications and conduct.
