April 30, 1998 - Introduced by LAW REVISION COMMITTEE. Referred to Committee on Judiciary.

1 **AN ACT relating to:** repealing, consolidating, renumbering, amending and
2 revising various provisions of the statutes for the purpose of correcting errors,
3 supplying omissions, correcting and clarifying references, eliminating defects,
4 anachronisms, conflicts, ambiguities and obsolete provisions, deleting,
5 reconciling conflicts and repelling unintended repeals (Revisor's Correction
6 Bill).

Analysis by the Legislative Reference Bureau

This revisor's correction bill is explained in the NOTES provided by the revisor of statutes bureau in the body of the bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

20 whom is a consumer representing the public at large, with demonstrated

6 majority party and the minority party in each house, chosen as are the members of
7 standing committees in their respective houses. Section 15.09 applies to the council.

The purpose of the change was to provide that inspection under this provision was not to be allowed where injury to anyone would result from inspection by anyone with inspection rights. The insertion of "child" is necessary to provide that harm from inspection by anyone with inspection rights can be prevented.
