



## 1997 ASSEMBLY BILL 971

April 30, 1998 - Introduced by LAW REVISION COMMITTEE. Referred to Committee on Judiciary.

1 **AN ACT relating to:** repealing, consolidating, renumbering, amending and  
2 revising various provisions of the statutes for the purpose of correcting errors,  
3 supplying omissions, correcting and clarifying references and eliminating  
4 defects, anachronisms, conflicts, ambiguities and obsolete provisions. (Section  
5 13.93 (2) (i) Revision Bill).

### *Analysis by the Legislative Reference Bureau*

This bill is drafted pursuant to s. 13.93 (2) (j), stats., for the purpose of modernizing statutory structure and language and increasing conformity with current drafting style in order to improve user readability and accessibility. Throughout this bill the word form of numbers are replaced by digits, disfavored language is replaced with preferred terms and spellings, long sentences and statutory units are subdivided or otherwise shortened and nonspecific articles and references are replaced. Some punctuation is changed to accommodate the other changes. NOTES provided by the revisor of statutes bureau in the body of the bill indicate treatments made to the specific statutory units. No substantive changes are intended.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

6 **SECTION 1.** 30.33 (1) of the statutes is amended to read:  
7 30.33 (1) BOARD TO HAVE POWERS OF RAILROAD CORPORATION. Any municipality  
8 operating a public harbor through a board of harbor commissioners may, through

1 such board, construct, maintain or operate railway facilities or a harbor belt line  
2 connecting various harbor facilities with one another or with other railroads within  
3 the municipality or its vicinity. The board of harbor commissioners is granted all of  
4 the rights, powers and privileges conferred upon railroad corporations by ~~s.~~ ss.  
5 190.02 and 190.025 (3), except such rights, powers and privileges as are conferred  
6 upon railroad corporations by s. 190.02 (9). Such facilities or belt line may be  
7 constructed, maintained or operated partly outside the corporate limits of the  
8 municipality. In constructing, maintaining or operating such facilities or belt line,  
9 the board of harbor commissioners has the powers and privileges of railroad  
10 corporations and shall be subject to the same restrictions as railroad corporations  
11 and to the supervision of the office of the commissioner of railroads, except as to the  
12 system of accounting and the payment of wages to employes.

13 **SECTION 2.** 134.245 of the statutes is created to read:

14 **134.245 Definitions.** In ss. 134.25 to 134.32:

15 (1) "Marked" means stamped, branded, engraved or imprinted upon, attached  
16 to a tag, card or label which is stamped, branded, engraved or imprinted upon, or  
17 contained in a box, package, cover or wrapper which is stamped, branded, engraved  
18 or imprinted upon.

19 (2) "Person" means an individual, firm, corporation or association.

20 (3) "Sells" includes making for sale, selling, offering to sell or dispose of, or  
21 possessing with intent to sell or dispose of.

NOTE: Creates definitions provision to simplify ss. 134.25 to 134.32.

22 **SECTION 3.** 134.25 (1) of the statutes is renumbered 134.25 (1) (a) and amended  
23 to read:

1           134.25 (1) (a) ~~Any~~ Except as provided in par. (b) and subject to sub. (3), any  
2           person, firm, corporation or association, who or which makes for sale, or sells, or  
3           offers to sell or dispose of, or has in his, her or its possession with intent to sell or  
4           dispose of, who sells any article of merchandise made in whole or in part of gold or  
5           any alloy of gold, ~~and having stamped, branded, engraved or imprinted thereon, or~~  
6           upon any tag, card or label attached thereto, or upon any box, package, cover or  
7           wrapper in which said article is encased or enclosed that is marked in any mark, way  
8           indicating, or designed or intended to indicate, that the gold or alloy of gold in such  
9           the article is of a greater degree of fineness than the actual fineness or quality of such  
10          the gold or alloy, ~~unless the actual fineness of such gold or alloy, in the case of flat~~  
11          ware and watch cases, be not less by more than three one-thousandths parts, and  
12          in the case of all other articles be not less by more than one-half karat than the  
13          fineness indicated by the marks stamped, branded, engraved or imprinted upon any  
14          part of such article, or upon any tag, card or label attached thereto, or upon any box,  
15          package, cover or wrapper in which such article is encased or enclosed, according to  
16          the standards and subject to the qualifications hereinafter set forth, is guilty of a  
17          misdemeanor.

NOTE: Deletes redundant language, replaces parentheses and inserts specific references. Simplifies structure by making long phrases definitions under s. 134.245 and making exception to liability a separate par. (b). See also the previous and next sections of this bill.

18           **SECTION 4.** 134.25 (1) (b) of the statutes is created to read:

19           134.25 (1) (b) Paragraph (a) is not violated if the actual fineness of the gold or  
20          alloy in the article meets any of the following conditions:

21           1. The actual fineness is not less, by more than three one-thousandths parts  
22          in the case of flatware and watch cases, than the fineness actually marked on the  
23          article.

1           2. The actual fineness is not less, by more than one-half karat, than the  
2 fineness actually marked on the article in the case of all articles not specified in subd.  
3 1.

NOTE: Moves liability exception to separate provision to simplify s. 134.25

4           **SECTION 5.** 134.25 (2) and (3) of the statutes are amended to read:

6 gold or its alloy in any ~~such~~ article, according to the ~~foregoing~~ standards set forth in  
7 this section, the part of the gold or ~~of its~~ gold alloy taken for the test, ~~analysis or assay~~  
8 ~~shall be such part or portion as~~ does not contain or have attached thereto to it any  
9 solder or alloy of inferior fineness used for brazing or uniting the parts of ~~said the~~  
10 article.

11           (3) ~~In addition to the foregoing tests and standards, that the~~ The actual  
12 fineness of the entire quantity of gold and ~~of its~~ gold alloys contained in any article  
13 mentioned in this section (~~, except watch cases and flat ware~~) flatware, including all  
14 solder or alloy of inferior metal used for brazing or uniting the parts of the article (~~all~~  
15 ~~such gold, alloys and solder being assayed as one piece~~), shall not be less, by more  
16 than one karat, than the fineness indicated by the mark ~~stamped, branded, engraved~~  
17 ~~or imprinted upon such~~ marked on the article, or upon any tag, card or label attached  
18 ~~thereto, or upon any box, package, cover or wrapper in which said article is encased~~  
19 ~~or enclosed.~~ In determining the quality of gold and gold alloys for purposes of this  
20 subsection, the gold, alloys and solder being tested shall be tested as one piece.

21           **SECTION 6.** 134.26 of the statutes is amended to read:

22           **134.26 Misbranding of sterling silver articles.** (1) ~~Any~~ Except as provided  
23 in sub. (2) and s. 134.29, any person, firm, corporation or association, who or which

1 makes for sale, or sells, or offers to sell or dispose of, or has in his, her or its possession  
2 with intent to sell or dispose of, who sells any article of merchandise made in whole  
3 or in part of silver or of any alloy of silver and having marked, stamped, branded,  
4 engraved or imprinted thereon, or upon any tag, card or label attached thereto or  
5 upon any box, package, cover or wrapper in which said article is encased or enclosed,  
6 with the words “sterling silver” or “sterling;” or any colorable imitation thereof of  
7 “sterling silver” or “sterling” unless nine hundred twenty-five one-thousandths of  
8 the component parts of the metal appearing or purporting to be silver, ~~of which such~~  
9 article is manufactured are pure silver, subject to the qualifications hereinafter set  
10 forth, is guilty of a misdemeanor.

11 (2) In the case of all such articles that are subject to sub. (1), there shall be  
12 allowed a divergence in fineness of four one-thousandths parts from the foregoing  
13 standards under sub. (1).

18 with intent to sell or dispose of, who sells any article of merchandise made in whole  
19 or in part of silver or of any alloy of silver and having marked, stamped, branded,  
20 engraved or imprinted thereon, or upon any tag, card or label attached thereto, or  
21 upon any box, package, cover or wrapper in which such article is encased or enclosed,  
22 with the words “coin” or “coin silver;”, or any colorable imitation thereof of “coin” or  
23 “coin silver”, unless nine hundred one-thousandths of the component parts of the

1 metal appearing or purporting to be silver, ~~of which such article is manufactured~~ are  
2 pure silver, ~~subject to the qualifications hereinafter set forth,~~ is guilty of a  
3 misdemeanor.

14 ~~cover or wrapper in which said article is encased or enclosed, any mark or word (~~

5 ~~of, who sells~~ any article of merchandise made in whole or in part of inferior metal,  
6 having deposited or plated ~~thereon~~ on the inferior metal or brazed or otherwise  
7 affixed ~~thereto~~ to the inferior metal, a plate, plating, covering or sheet of silver or of  
8 any alloy of silver, ~~and which article is known in the market as “silver plate” or “silver~~  
9 ~~electroplate,”~~, or by any similar designation, ~~and having stamped, branded,~~  
10 ~~engraved or imprinted thereon, or upon any tag, card or label attached thereto, or~~

20 violation of ss. 134.25 to 134.31, shall be ~~punished by a fine of not~~ fined not less than

Simplifies structure by making long phrases definitions under s. 134.245. There can be no violation of s. 134.32 as its sole function is to provide penalties for violations of other sections.

12 **to the school fund of such town apportioned in the same manner as tax revenues**  
13 **collected by the town for schools under s. 60.33 (9) (d).**

NOTE: Subdivides provision, breaks up long sentence, replaces word form of numbers with digits and other language. There is no town school fund. This term was inserted by the editors of the revised statutes of 1878. The replacement language inserted by this bill reflects the original language of Chapter 69, Laws of 1869, as updated to reflect current s. 60.33 (9) (d).

14            **SECTION 21.** 171.02 of the statutes is renumbered 171.065 and amended to read:

15            **171.065 Disposition of proceeds.** If the owner of the property sold under this  
16 chapter or the owner's legal representatives shall, at any time within five 5 years
