



## 1997 SENATE JOINT RESOLUTION 47

April 21, 1998 - Introduced by COMMITTEE ON SENATE ORGANIZATION.

1 **Relating to:** revival of specified proposals for further consideration.

1           **SECTION 2. Rereferral of pending business.** Upon adoption of this joint  
2 resolution by the senate and concurrence by the assembly all of the proposals under  
3 SECTION 1 that were in a standing or special committee of the senate upon  
4 adjournment on March 26, 1998, shall be withdrawn from those committees and  
5 returned to the office of the chief clerk, to be rereferred by the presiding officer to the  
6 appropriate committee of the senate as determined by the presiding officer.
