2015 SENATE BILL 208

July 2, 2015 – Introduced by Senators CARPENTER, RISSER and RINGHAND, cosponsored by Representatives KAHL, HESSELBEIN, SARGENT, ZEPNICK, CONSIDINE and OHNSTAD. Referred to Committee on Elections and Local Government.

1 **AN ACT** *to repeal* 5.35 (6) (b), 5.51 (7), 5.81 (4), 5.91 (6), 7.50 (1) (d) and 8.50 (3)
2 (c); *to renumber and amend* 5.37 (4); and *to amend* 5.02 (16m), 5.62 (1), 5.62
3 (2), 5.62 (3), 5.655 (1), 5.84 (1), 5.91 (1) and (3), 6.80 (2) (am), 6.80 (2) (f), 6.87
4 (4) (b) 1., 7.08 (2) (b), 7.50 (2) (g), 8.16 (1), (6) and (7), 8.17 (1) (a), 8.20 (9), 8.50
5 (3) (b), 9.10 (3) (e), 10.02 (3) (b) 2. and 11.06 (7m) (a) of the statutes; **relating**
6 **to:** authorization for electors to vote in the primary of more than one political
7 party.

Analysis by the Legislative Reference Bureau

Presently, a voter in a partisan primary election may cast a ballot or vote in the column of only one major political party, regardless of the number of candidates who are running for office in that party, if any. Similarly, a voter in a partisan primary may vote for any of the independent candidates for state office, but if the voter chooses this option, he or she may not vote for any party candidates for any office. (Candidates of minor parties appear on the ballot as independent candidates.)

This bill permits a voter in a partisan primary to “split tickets,” designating the candidate of his or her choice for each office, including the offices of governor and lieutenant governor, regardless of party affiliation. The bill also allows a voter to vote for independent candidates for one or more state offices in a partisan primary, in addition to party candidates for one or more state or county offices. Under the bill,

a voter may still vote for only one candidate for each office. The voting procedure at the general election and other partisan elections is unaffected by the bill.

The bill initially applies to voting at the 2016 partisan primary election.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

1 **SECTION 1.** 5.02 (16m) of the statutes is amended to read:

2 5.02 (16m) "Recognized political party" means a political party which ~~that~~

10 (a) Each candidate's name entitled to appear on the ~~ballots~~ ballot at the
11 primary and the party that he or she represents shall appear on the machine; the
12 elector ~~cannot vote for candidates of more than one party, whenever the restriction~~
13 ~~applies; the elector may secretly select the party for which he or she wishes to vote;~~
14 ~~the.~~

15 (b) The elector may vote for as many candidates for each office as he or she is
16 lawfully entitled to vote for, but no more.

5 column or row, except as authorized in s. 5.655. ~~The ballots shall be secured together~~
6 ~~at the bottom.~~ The ~~party ballot~~ column or row of the party receiving the most votes
7 for president or governor at the last general election shall be ~~on top~~ first with the
8 other parties arranged in descending order based on their vote for president or

20 political party listed on the official ballot at the last gubernatorial election whose
21 candidate for any statewide office received at least ~~1%~~ 1 percent of the total votes cast
22 for that office and, if the last general election was also a presidential election, every
23 recognized political party listed on the ballot at that election whose candidate for
24 president received at least ~~1%~~ 1 percent of the total ~~vote~~ votes cast for that office shall

7 same procedure as provided in s. 5.60 (1) (b). On each ~~ballot and on each~~ separate
8 column or row on the ballot, the candidates for office shall be listed together with the
9 offices ~~which~~ that they seek in the following order whenever these offices appear on
10 the partisan primary ballot: governor, lieutenant governor, attorney general,
11 secretary of state, state treasurer, U.S. senator, U.S. representative in congress,

18 ballot that is authorized under sub. (2). If a municipality uses a single ballot in lieu
19 of separate ballots, the ballot shall include a separate column or row for any office,
20 or referendum or party for which a separate ballot is required by law and the ballot
21 shall be distributed only to electors who are eligible to vote for all of the offices and
22 referenda appearing on the ballot.

3 central counting location, the municipal clerk shall, on any day not more than 10

5 equipment tested to ascertain that it will correctly count the votes cast for all offices
6 and on all measures. Public notice of the time and place of the test shall be given by
7 the clerk at least 48 hours prior to the test by publication of a class 1 notice under
8 ch. 985 in one or more newspapers published within the municipality if a newspaper
9 is published therein, otherwise in a newspaper of general circulation therein. The
10 test shall be open to the public. The test shall be conducted by processing a
11 preaudited group of ballots so marked as to record a predetermined number of valid
12 votes for each candidate and on each referendum. The test shall include for each
13 office one or more ballots ~~which~~ that have votes in excess of the number allowed by
14 law ~~and, for a partisan primary election, one or more ballots which have votes cast~~
15 ~~for candidates of more than one recognized political party,~~ in order to test the ability
16 of the automatic tabulating equipment to reject such votes. If any error is detected,
17 the municipal clerk shall ascertain the cause and correct the error. The clerk shall
18 make an errorless count before the automatic tabulating equipment is approved by
19 the clerk for use in the election.

20 **SECTION 11.** 5.91 (1) and (3) of the statutes are amended to read:

21 5.91 (1) It enables an elector to vote in secrecy ~~and to select the party for which~~
22 ~~an elector will vote in secrecy at a partisan primary election.~~

23 (3) ~~Except in primary elections, it~~ It enables an elector to vote for a ticket
24 selected in part from the nominees of one party, and in part from the nominees of
25 other parties, and in part from independent candidates and, except in the case of

3 **SECTION 12.** 5.91 (6) of the statutes is repealed.

4 **SECTION 13.** 6.80 (2) (am) of the statutes is amended to read:

5 6.80 (2) (am) In partisan primaries, an elector may vote for a person as the
6 candidate of the party of the elector's choice, if that person's name does not appear
7 on the official ballot of ~~that party~~, by writing in the name of the person in the space
8 provided on the ballot or the ballot provided for that purpose, or where voting
9 machines are used, in the irregular ballot device, designating the party for which the
10 elector desires such person to be the nominee.

11 **SECTION 14.** 6.80 (2) (f) of the statutes is amended to read:

12 6.80 (2) (f) In the presidential preference primary ~~and other partisan primary~~
13 elections at polling places where ballots are distributed to electors, unless the ballots
14 are prepared under s. 5.655 or are utilized with an electronic voting system in which
15 all candidates appear on the same ballot, after the elector prepares his or her ballot
16 the elector shall detach the remaining ballots, fold the ballots to be discarded and fold
17 the completed ballot unless the ballot is intended for counting with automatic
18 tabulating equipment. The elector shall then either personally deposit the ballots
19 to be discarded into the separate ballot box marked "blank ballot box," and deposit
20 the completed ballot into the ballot box indicated by the inspectors, or give the ballots
21 to an inspector who shall deposit the ballots directly into the appropriate ballot
22 boxes. The inspectors shall keep the blank ballot box locked until the canvass is
23 completed and shall dispose of the blank ballots as prescribed by the municipal clerk.

3 adult U.S. citizen. The absent elector, in the presence of the witness, shall mark the
4 ballot in a manner that will not disclose how the elector's vote is cast. The elector
5 shall then, still in the presence of the witness, fold the ballots so each is separate and
6 so that the elector conceals the markings thereon and deposit them in the proper
7 envelope. If a consolidated ballot under s. 5.655 is used, the elector shall fold the
8 ballot so that the elector conceals the markings thereon and deposit the ballot in the

7 nominated under s. 8.20 shall be sent as soon as possible after the closing date for
8 filing nomination papers, but no later than the deadlines established in s. 10.06.

11 structure of a political party. Committeemen and committeewomen shall act as

13 districts in which they serve. Activities of committeemen and committeewomen
14 shall include, but not be limited to, identifying voters; assistance in voter
15 registration drives; increasing voter participation in political parties; polling and
16 other methods of passing information from residents to political parties and elected
17 public officials; and dissemination of information from public officials to residents.

20 activities in each ward, if the election district served by the committeeman or

1 8.20 (9) Persons nominated by nomination papers without a recognized
2 political party designation shall be placed on the official ballot at the general election
3 and at any partisan election to the right or below the recognized political party
4 candidates in their own column or row designated "Independent". If the candidate's
5 name already appears under a recognized political party it may not be listed on the
6 independent ballot, column or row.

7 **SECTION 22.** 8.50 (3) (b) of the statutes is amended to read:

8 8.50 (3) (b) Except as otherwise provided in this section, the provisions for the
9 partisan primary under s. 8.15 are applicable to all partisan primaries held under
10 this section, and the provisions for spring primaries under s. 8.10 are applicable to
11 all nonpartisan primaries held under this section. In a special partisan primary or
12 election, the order of the parties on the ballot shall be the same as provided under
13 s. 5.62 (1) or 5.64 (1) (b). No primary is required for a nonpartisan election in which
14 not more than 2 candidates for an office appear on the ballot or for a partisan election
15 in which not more than one candidate for an office appears on in the ballot column
16 or row of each recognized political party on the ballot. In every special election except
17 a special election for nonpartisan state office where no candidate is certified to
18 appear on the ballot, a space for write-in votes shall be provided on the ballot,
19 regardless of whether a special primary is held.

22 9.10 (3) (e) For any partisan office, a recall primary shall be held for each

24 primary ballot under s. 5.62 (1) (b) or (2) and from which more than one candidate
25 competes for the party's nomination in the recall election. The primary ballot shall

2 the highest number of votes in the recall primary for each political party shall be that

9 elector intends to vote, or shall insert or write in the name of the elector's choice for
10 a candidate.

11 **SECTION 26.** 11.06 (7m) (a) of the statutes is amended to read:

12 11.06 (7m) (a) If a committee ~~which~~ that was registered under s. 11.05 as a
13 political party committee or legislative campaign committee supporting candidates
14 of a political party files an oath under sub. (7) affirming that it does not act in
15 cooperation or consultation with any candidate who is nominated to appear on the
16 ~~party~~ ballot in the column or row of the party at a general or special election, that
17 the committee does not act in concert with, or at the request or suggestion of, such
18 a candidate, that the committee does not act in cooperation or consultation with such
19 a candidate or agent or authorized committee of such a candidate who benefits from
20 a disbursement made in opposition to another candidate, and that the committee
21 does not act in concert with, or at the request or suggestion of, such a candidate or
22 agent or authorized committee of such a candidate who benefits from a disbursement
23 made in opposition to another candidate, the committee filing the oath may not make
24 any contributions in support of any candidate of the party at the general or special

3 **SECTION 27. Initial applicability.**

4 (1) This act first applies with respect to voting at the 2016 partisan primary
5 election.
