2019 SENATE JOINT RESOLUTION 82

January 15, 2020 - Introduced by Senators JOHNSON, DARLING, JACQUE, SCHACHTNER, CARPENTER, OLSEN, BEWLEY, RINGHAND, MILLER, WIRCH, L. TAYLOR, ERPENBACH and LARSON, cosponsored by Representatives BILLINGS, LOUDENBECK, VINING, EMERSON, PRONSCHINSKE, BOWEN, CROWLEY, VRUWINK, TUSLER, ANDERSON, KOLSTE, ZAMARRIPA, DITTRICH, HEBL, KERKMAN, JAMES, TITTL, STUBBS, SHANKLAND, HAYWOOD, SPIROS, MURSAU, KULP, VORPAGEL, SUBECK, SINICKI, GRUSZYNSKI, CABRERA, CONSIDINE, OHNSTAD, MURPHY, C. 1 **Relating to:** proclaiming January 2020 as human trafficking awareness and
2 prevention month.

3 Whereas, human trafficking occurs when a person is recruited, harbored,
4 obtained, or transported through force, fraud, or coercion for the purposes of sexual
5 exploitation, commercial sex acts, or labor exploitation; and

6 Whereas, human traffickers disproportionately target at-risk populations,
7 including individuals who have experienced or been exposed to other violence, such
8 as child abuse and maltreatment and community violence, and those who are
9 disconnected from support networks, such as runaway and homeless youth,
10 unaccompanied minors, and persons displaced by natural disasters; and

11 Whereas, more than 49,000 total cases of human trafficking have been reported
12 to the National Human Trafficking Hotline in the last ten years, averaging 150 calls
13 per day; and

14 Whereas, the average age a trafficking victim enters the sex trade in the U.S.
15 is 12 to 14 years old; and

1 Whereas, in 2018, an estimated one out of seven endangered runaways
2 reported to the National Center for Missing and Exploited Children were likely child
3 sex trafficking victims, 80 percent of all trafficking victims are female, and 50
4 percent of victims are children; and

5 Whereas, a 2019 U.S. State Department report found that advocates reported
6 a growing trend of traffickers targeting people with disabilities and an increase in
7 the use of online social media platforms to recruit and advertise victims of human
8 trafficking; and

9 Whereas, human trafficking has been reported in all 72 counties in the state,
10 and it is a crime found in rural, urban, and suburban communities; and

11 Whereas, human trafficking is modern-day slavery, a practice that is in direct
12 opposition to the fundamental principles of liberty and human rights upon which our
13 nation was founded; and

14 Whereas, to combat human trafficking in our state, our citizens must be aware
15 of the realities of human trafficking, educated to recognize victims of human
16 trafficking, and dedicated to stopping it; and

17 Whereas, a resolution passed by the U.S. Senate on June 22, 2007, has forever
18 marked January 11th as a day of awareness and vigilance for the countless victims
19 and survivors of human trafficking around the world; and

20 Whereas, Wisconsin has zero tolerance for human trafficking, and eliminating
21 human trafficking is a goal shared by all Americans who believe in freedom and
22 liberty for all people; now, therefore, be it
