## 2021 ASSEMBLY BILL 594

October 4, 2021 - Introduced by Representatives DITTRICH, SPIROS, PENTERMAN, KUGLITSCH, ALLEN, SUMMERFIELD, CALLAHAN, GUNDRUM, KNODL, TUSLER, KATSMAN, LOUDENBECK, ROZAR, SCHRAA, MURSAU, PLUMER and EDMING, cosponsored by Senators TESTIN, JAGLER, KAPENGA, BRADLEY, WANGGAARD, NASS, LEMAHIEU, COWLES, BERNIER and ROTH. Referred to Committee on Health.

1     **AN ACT** *to create* 253.135 of the statutes; **relating to:** congenital condition  
2           educational resources.

***Analysis by the Legislative Reference Bureau***

This bill requires physicians who administer a prenatal or postnatal test for a congenital condition and receive a positive test result to ensure the parent or expectant parent of the child with the positive test result receives certain educational resources on the congenital condition made available by the Department of Health Services. The educational resources may be provided electronically, or, if the parent or expectant parent prefers, physically. The educational resources that DHS must make available on its Internet site must include certain current, evidence-based information about the congenital condition that has been reviewed by medical experts and national organizations specializing in the congenital condition specified in the bill and supportive information relevant to the congenital condition that includes contact information as specified in the bill. The bill requires DHS to review and, as appropriate, update the educational resources with information from new studies and research. The bill also requires DHS to provide the educational resources in, at least, English and in Spanish and Hmong translations.

***The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:***

**ASSEMBLY BILL 594****SECTION 1**

1           **SECTION 1.** 253.135 of the statutes is created to read:

2           **253.135 Congenital conditions. (1) DEFINITIONS.** In this section:

3           (a) “Congenital condition” means a genetic or other congenital disease or  
4 condition, including Down syndrome, that is capable of being detected through in  
5 utero diagnosis.

6           (b) “Down syndrome” means a genetic condition caused by cell division that  
7 results in the presence of an extra whole or partial copy of chromosome 21.

8           **(2) REQUIREMENT TO PROVIDE EDUCATIONAL RESOURCES.** Any physician who  
9 administers a prenatal or postnatal test for a congenital condition and receives a  
10 positive test result for a congenital condition shall ensure that the parent or  
11 expectant parent of a child with the positive test result receives all of the educational  
12 resources described under sub. (3). The educational resources may be provided  
13 electronically by electronic mail or another digital or electronic means of  
14 communication or, if the parent or expectant parent prefers, physically by a copy of  
15 the resources obtained from the department’s Internet site.

16           **(3) EDUCATIONAL RESOURCES.** (a) The department shall make available to  
17 physicians described in sub. (2) through a link on its Internet site educational  
18 resources on the congenital condition that include all of the following:

19           1. Current, evidence-based information about the congenital condition that  
20 has been reviewed by medical experts and national organizations specializing in that  
21 congenital condition and that contains all of the following:

22           a. Possible physical, developmental, educational, and psychosocial outcomes  
23 of the congenital condition.

24           b. Life expectancy for individuals with a diagnosis of the congenital condition.

25           c. Clinical course of the congenital condition.

1           d. Intellectual and functional development for individuals with a diagnosis of  
2 the congenital condition.

3           e. Treatment options for the congenital condition.

4           f. Any other information related to the congenital condition the department  
5 determines is necessary.

6           2. Supportive information relevant to the congenital condition that includes  
7 contact information for all of the following:

8           a. Informational hotlines specific to the congenital condition.

9           b. Relevant resource centers.

10          c. National and local organizations with a focus on the congenital condition.

11          d. Educational and support programs.

12          (b) The department shall periodically review the educational resources under  
13 par. (a) 1. and 2. and, as appropriate, shall update the educational resources with  
14 information from new studies or research that is released or discovered related to  
15 congenital conditions.

16          (c) The department shall provide the educational resources under par. (a) 1. and  
17 2. in, at least, Spanish and Hmong translations in addition to English.
