## 2023 SENATE BILL 829

December 19, 2023 - Introduced by Senators WANGGAARD and CABRAL-GUEVARA, cosponsored by Representatives TUSLER, BEHNKE, BODDEN, DITTRICH, DONOVAN, EDMING, GUNDRUM, MAGNAFICI, MURPHY, ORTIZ-VELEZ and SCHRAA. Referred to Committee on Judiciary and Public Safety.

1     **AN ACT** *to amend* 165.85 (3) (a), 165.85 (3) (c), 165.85 (3) (cm) (intro.), 5. and 6.,  
2             175.44 (1) (b) and 943.13 (4m) (bm); and *to create* 29.089 (2) (am), 29.091 (2)  
3             (am), 29.621 (4) (am), 165.85 (2) (fh), 165.85 (4) (am), 440.26 (3m) (am), 941.23  
4             (2) (am), 948.605 (2) (b) 2e. and 948.605 (3) (b) 5m. of the statutes; **relating to:**  
5             allowing a tactical emergency medical services professional to carry a firearm  
6             in prohibited areas.

### *Analysis by the Legislative Reference Bureau*

Current law prohibits a person from carrying a firearm in certain places, including in public buildings, police stations, jails, courthouses, school zones, and places that are marked with a notification that it is trespassing to carry a firearm while on the property. Current law provides many exceptions, including an exception for law enforcement officers acting in the line of duty. This bill adds an exception that mirrors the exception for law enforcement officers for a tactical emergency medical services professional who is certified as such by the Law Enforcement Standards Board and acting in the line of duty. The bill defines a TEMS professional as a licensed emergency medical services professional who has been endorsed by the Department of Health Services as a person who provides medical services when operating as part of a tactical team

Under current law, the Law Enforcement Standards Board regulates the training and recertification training of law enforcement officers. As part of

recertification training, an officer must complete an annual handgun operation qualification course. This bill requires LESB to establish minimum training standards to certify TEMS professionals, including the same annual handgun operation qualification course required for law enforcement officers.

9 officers, tactical emergency medical services professionals, jail officers, or juvenile  
10 detention officers. Prior to being certified under this paragraph, a tribal law  
11 enforcement officer shall agree to accept the duties of law enforcement officers under  
12 the laws of this state.

13 **SECTION 7.** 165.85 (3) (cm) (intro.), 5. and 6. of the statutes are amended to read:

14 165.85 (3) (cm) (intro.) Decertify law enforcement officers, tribal law  
15 enforcement officers, tactical emergency medical services professionals, jail officers,  
16 or juvenile detention officers who do any of the following:

17 5. Are convicted of a felony or of any offense that, if committed in Wisconsin,  
18 could be punished as a felony. A law enforcement officer or tactical emergency  
19 medical services professional so convicted shall notify the board within 30 days of his  
20 or her conviction.

21 6. Are convicted of a misdemeanor crime of domestic violence, as defined in 18  
22 USC 921 (a) (33), or are convicted of domestic abuse, as defined in s. 968.075 (1) (a),  
23 or the conviction is subject to the imposition of the domestic abuse surcharge under  
24 s. 973.055 (1), regardless of whether any part of the surcharge is waived by the court  
25 under s. 973.055 (4). A law enforcement officer or tactical emergency medical

2 conviction.

3 **SECTION 8.** 165.85 (4) (am) of the statutes is created to read:

4 165.85 (4) (am) *Tactical emergency medical services professionals.* 1. The board  
5 shall establish minimum training standards for tactical emergency medical services  
6 professionals. In establishing the minimum training standards, the board shall  
7 consider recommendations made by the curriculum advisory committee. The board  
8 may amend the standards as needed to respond to technological changes affecting  
9 law enforcement or tactical emergency medical services, additional  
10 recommendations made by the curriculum advisory committee, or other conditions  
11 affecting the public interest in maintaining training standards of a proper  
12 professional character. Notwithstanding s. 227.10 (1), the standards established  
13 under this subdivision need not be promulgated as rules under ch. 227.

14 2. No person may be certified as a tactical emergency medical services  
15 professional, except on a temporary or probationary basis, unless the person has  
16 satisfactorily met the standards established under subd. 1. and has been certified by  
17 the board as being qualified to be a tactical emergency medical services professional.

18 3. A person who has met the minimum training standards established under  
19 subd. 1., and who seeks certification as a tactical emergency medical services

5 violence, or of any offense that, if committed in Wisconsin, could be punished as a  
6 felony qualifies for certification as a tactical emergency medical services professional  
7 unless he or she has been granted an absolute and unconditional pardon for the  
8 crime.

9 5. a. No person may continue to be certified as a tactical emergency medical  
10 services professional unless that person maintains employment as a tactical  
11 emergency medical services professional and meets annual recertification training  
12 standards. A tactical emergency medical services professional who is subject to this  
13 subdivision shall meet the recertification standards each fiscal year beginning in the  
14 fiscal year following the fiscal year in which he or she is certified as a tactical  
15 emergency medical services professional by the board.

16 b. Each tactical emergency medical services professional who is subject to this  
17 subdivision shall annually complete a handgun qualification course from curricula

5 services professional under s. 165.85 (3) while acting in the line of duty.

6 **SECTION 12.** 943.13 (4m) (bm) of the statutes is amended to read:

7 943.13 (4m) (bm) Subsection (1m) (c) 2. and 4. does not apply to a law  
8 enforcement officer employed in this state by a public agency to whom s. 941.23 (1)  
9 (g) 2. to 5. and (2) (b) 1. to 3. applies, to a tactical emergency medical services  
10 professional certified under s. 165.85 (3) acting in the line of duty, to a qualified
